beg to submit the following few lines

for you kind consideration and necessary action.

That on 04-03-2023, at about 3:00 am, some unknown persons numbering about 2000 belonging to KUKI community started attacking the undersigned along with family members. Thereafter, the KUKI people started destroyed and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewellerys were also burned/destroyed/stolen before burning/damage.

KONTHOUJAM TEMBA SINGH MEITEI - 28 yrs

In the said incident one my son was dead namdy, was badly injured due to pelting of stones/hacking with knife/ shot form firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself my cause the arrest of the miscreants who belongs to the KUKI community involved in the burning/dismantling/ damaging my properties and one my son was dead injuring and take and FIR against them as soon as possible for the interest of justice.
