In the said incident one my son was dead manualy, was badly injured due to pelting of stones/hacking with knife/ shot form firearms toward us by the miscreants. A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application. In the above facts and circumstances, it is therefore respectfully requested that your goodself my cause the arrest of the miscreants who belongs to the KUKI community involved in the one my son was dead burning/dismantling/ damaging my properties and injuring_ and take and FIR against them as soon as possible for the interest of justice.
