Presently self along with my family members are staying at Relief camp open at Moirang Multipurpose Hr. Sec. School. The place of occurrence/scene of crime falls under Churachandpur Police Station but due to prevailing law and order situation I am not able to report at Churachandpur Police Station for my Complaint/report.
