I have the honour to report that, I am born and brought up at Khuga Tampak, Zoveng Meitei Leikai, Churachandpur District Manipur and living with my family of 5 members. I am businessman by profession. On i.e., 03/05/2023 at around 10:00 p.m. one of my grocery shops comprising of 3 rooms was set on fire by some Kuki Tribes riots by holding guns, swords, sticks, etc. and looted grocery items worth 5 lakhs. Further, on 04/05/2023 at around 10:00 a.m. they also stormed at my house Khuga Tampak, Zoveng Meitei Leikai, C.C.Pur District Manipur and looted 6 numbers of cooking gas cylinder, some Gold Ornaments worth 2 lakhs and Rs. 3,00,000/- in cash including many important documents viz. Land patta, registration certificate of vehicles and many more. Beside this, they destroyed the said house and burned downed all the household items including 5 Godrej's, 3 beds, TV, Fridge, Washing Machine, VIP Sofa set, etc. Luckily, AR deployed at C.C.Pur helped my family escaped from their brutal and merciless acts. Their illegal acts lead to many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is therefore request you to kindly take up necessary action against those Kuki tribes , rioters for their illegal and brutal acts as per law.
