I am businessman by profession. On i.e., 03/05/2023 at around 10:00 p.m. one of my Collection Store was set on fire by some Kuki Tribes riots by holding guns, swords, sticks, etc. and looted store items worth 18 lakhs and burned downed my personal vehicle bearing No. WB34AK1915 while parking. Luckily, AR deployed at C.C.Pur helped my family escaped from their brutal and merciless acts. Their illegal acts lead to many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is therefore request you to kindly take up necessary action against those Kuki tribes rioters for their illegal and brutal acts as per law.
