In the said incident our house and properties was dismantling badly due to pelting of stones/hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/damaging my properties and kindly take up an FIR against them as soon as possible for the interest of justice.
