With due respect, I, the undersigned namely Hemam Dinamari Meitei

aged about 47 years, resident of Khuga Meitei Christian Leikai,  
Zenhang Lamka beg to submit the following few lines for your consideration and necessary action.

That on 3/5/23 at about 11:00 PM, some unknown persons numbering about  
200 belonging to Kuki and Kuki community started attacking the undersigned along with family  
members. Thereafter, the Kuki people started destroying and burning the house of the undersigned  
resulting in all the properties of the undersigned were razed to the ground and all the belongings items  
were stolen before burning/damages.

In the said incident, ..... was badly injured due to pelting of  
stones/hacking with knife/shot from the firearms towards us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with  
the present application.

In the light of the above facts and circumstances, it is therefore respectfully requested that  
your good self may cause the arrest of the miscreants who belongs to the Kuki community involved in  
the burning/dismantling/damaging my properties and injuring ..... and take up an  
FIR against them as soon as possible in the interest of justice and urge to the concern authorities to  
compensate for those who expired and damages all the properties belongs to. List of items to be  
compensated are shown as Annexure.
