I, the undersigned, have the honour to state that large number of innumerable unidentified groups of people belonged to Kuki Community with deathly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabitate areas of

D - Phailien, Leimaram Leikai C.C.Pur and surrounding areas on 3rd May, 2023 in evening and thereon. The said unidentified Kuki groups vandalized / burnt down and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 37,00,000/- (thirty seven lacs) only.

After the said unfortunate incident, my family were fleeing our village and now we are taking shelter at a Relief Camp situated at Terakhongshangbi Mamang Leikai under Moirang P.S. Bishnupur District, Manipur.

It is therefore, prayed that the respected sir to kindly initiate and take necessary legal actions against the accused persons and the persons involved in the said inhuman acts and heinous crime, as per law of the land as soon as possible.
