

Subject: Report of criminal intimidation and un-lawful displacement
Sangaikot Police Station
Churachandpur, Manipur

Sir,

I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent residents and native of T. Lalaphei village, P.O.&P.S. Sangaikot District Churachandpur Manipur and that because of the ethnic conflict prevalent in the State, some unknown well-armed miscreants belonging to the Meetei/Meitei community on being targeting our village and its villagers to gutted down our houses and bodily harm the people to the extent of death, with no means of defense and security from the State's Government leaving us hapless. On being feared for our life, I along with my family members deserted our village on 28 May, 2023.

The total estimated amount of all the assets that was left behind at the mercy of the above mentioned well-armed Meetei/Meitei miscreants is worth Rs 85 thousand (approx).

I, therefore kindly request you to please take action in this matter and come up with positive solution.
