Sir.

I have the honour to state that today i.e. 29/11/2023 at about 09.10 am, received a reliable information about the presence of some active members of unlawful underground organisation in and around Paona Bazar and Wahengbam Leikai area with a view to commit prejudicial activities like extortion of money from the business establishments at said area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking at New Khwai Bridge, near Masjid Road. During that one Hyundai Creta Car white in colour without registration number coming from Masjid Road towards our frisking zone was stopped for checking and verification. On spot checking one person who later on identified himself as Yumnam Anandkumar Meitei (34 yrs) S/o. Y. Nabachandra Meitei of Yairipok Top Chingtha Oinam Thong Leirak, Imphal East District was found driving the said vehicle. On spot body searched (i) one Redmi 9 Prime mobile along with 2(two) SIM cards i.e. (a) one JIO SIM card bearing no. 89918650400092724568 (Phone No. 6009230300 as disclosed by him) and (b) one Vodafone SIM card bearing no. is treated as 89917552610475152805Y (Phone No. 8794341654 as disclosed by him) and (ii) one wallet black in colour containing a sum of Rs. 470/- (four hundred and seventy only) and one Aadhaar card were recovered from his possession.

On spot checking the said vehicle 1(one) box containing 15 (fifteen) strips of Spano-Croxywon-Plus capsules containing 8 capsules in each strip (a total of 120 capsules) was also recovered from the back trunk/boot of the said vehicle. On asking about the capsules, he disclosed that the above recovered capsules were bought one week back from one Amjad Khan (aged about 40 yrs), @ Ibai from Lilong Haoreibi. On further asking the relevant documents of the said vehicle, he produced one Xerox copy of the vehicle registration certificate bearing registration number MN01AW7540 and one coloured Xerox copy of Pollution Under Control Certificate of the vehicle bearing registration number MN01AW7540 and was unable to Something produced any original documents relating the said vehicle. On checking the chassis number of the said vehicle it was found to be MALPC812LLM054250J (suspected to be tampered) which produced any original documents relating the said vehicle. On checking the chassis number of ce, city by was different from the chassis number written on the Xerox copy of the vehicle registration certificate bearing registration number MN01AW7540. On further asking about the said vehicle # 29/11/2022 he disclosed that the vehicle was kept at his residence since one month back by one Ningtamba, Officer-in-Canactive cadre of UNLF organisation. Hence, the above recovered articles along with the above City Police mentioned Hyundai Creta Car and the Xerox copy of the documents he produced were seized at Imphal West Distriction and he was arrested at the spot at 10:10 am by observing formalities.

> It is, therefore, the arrested person and seized articles are handed over to you for taking further necessary legal action against him.
