We were rescued by Armed Security Personal and provided shelter at a safe place in	
Churachandpur for the first few days.	
Later on, we have been evacuated to Relief Camp within Bishnupur District under armed	
escort. Hence, I was not able to report regarding this matter to the police on time. We are still in	N
