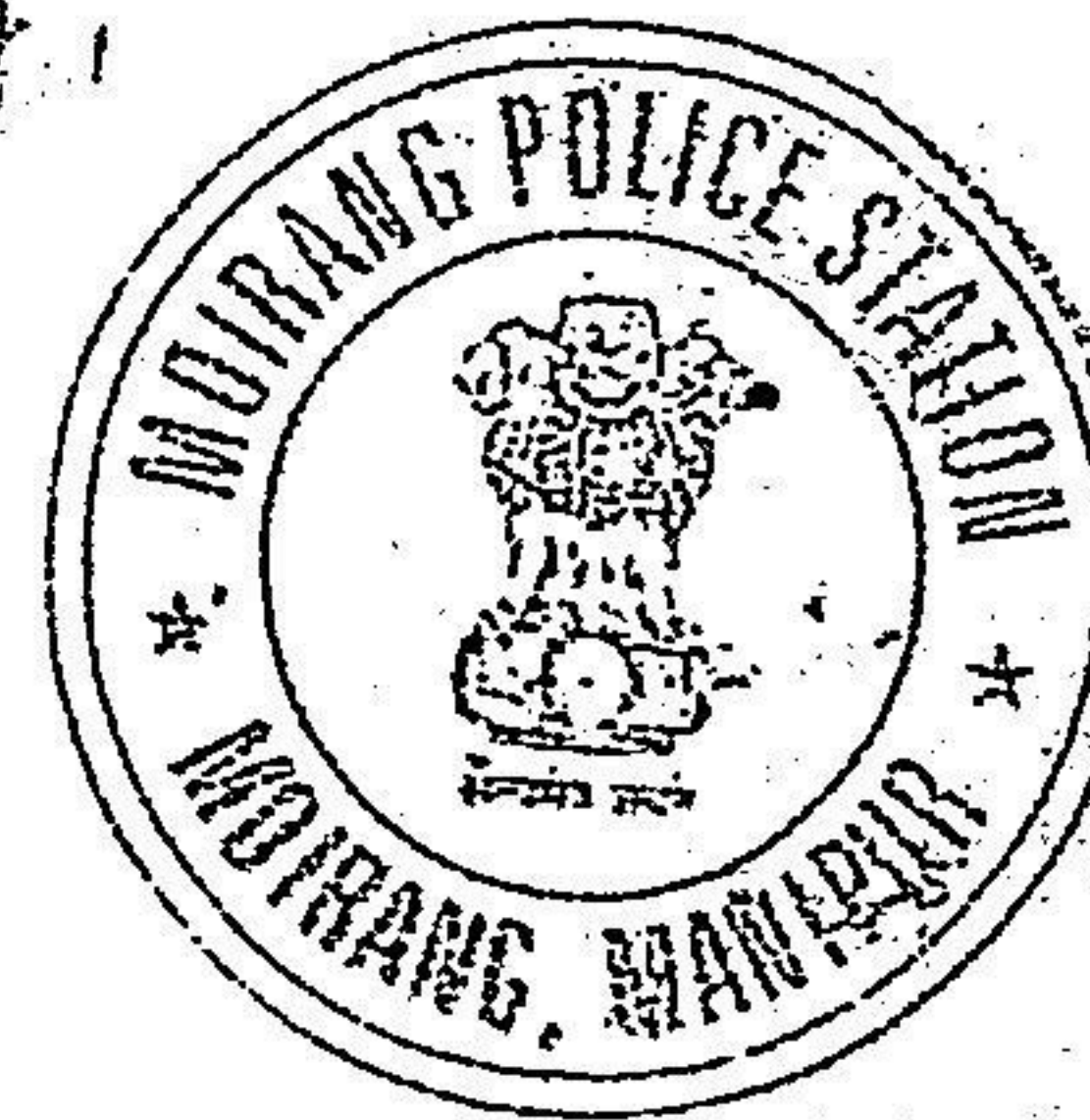

Subject: Report on losses in the recent communal clash and to take up an FIR.

Sir,

With due respect, I, the undersigned namely OINAM ANAND MEITEI,  
s/o, w/o OINAM BIREN aged about 87 years,  
resident of KHUGA TAMPAK MEITEI LEIKAI, Churachandpur beg to submit  
the following few lines for your kind consideration and necessary action.

That on 03<sup>rd</sup> May, 2023, at about 7:00 pm, some unknown armed persons  
numbering about 150 belonging to Kuki community started attacking the undersigned along  
with family members. Thereafter, the Kuki people started destroying and burning the house of the  
undersigned resulting in all the properties of the undersigned were razed to the ground and all the  
belongings and jewelries were also burned/destroyed / stolen before burning/ damage.

In the said incident \_\_\_\_\_ was badly injured due to pelting of  
stones/hacking with knife/shot from firearms toward us by the miscreants.

We were rescued by Armed Security Personal and provided shelter at a safe place in  
Churachandpur for the first few days.

Later on, we have been evacuated to Relief Camp within Bishnupur District under armed  
escort. Hence, I was not able to report regarding this matter to the police on time. We are still in  
the Relief camp at the time of filing this application.

In the above facts and circumstances, it is therefore respectfully requested that your  
goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in  
the burning/dismantling/ damaging my properties and injuring \_\_\_\_\_ and take up  
an FIR against them as soon as possible for the interest of justice.
