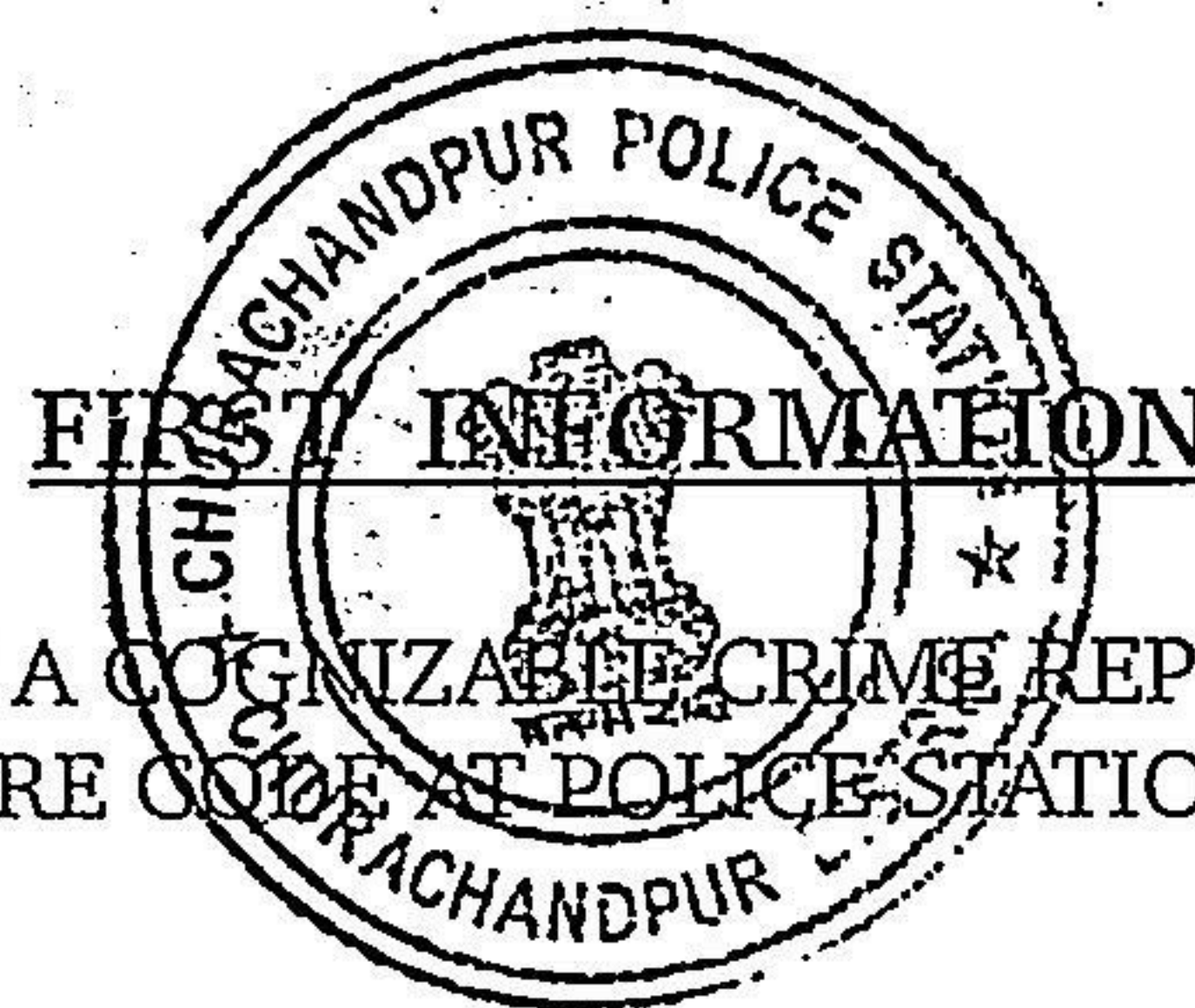

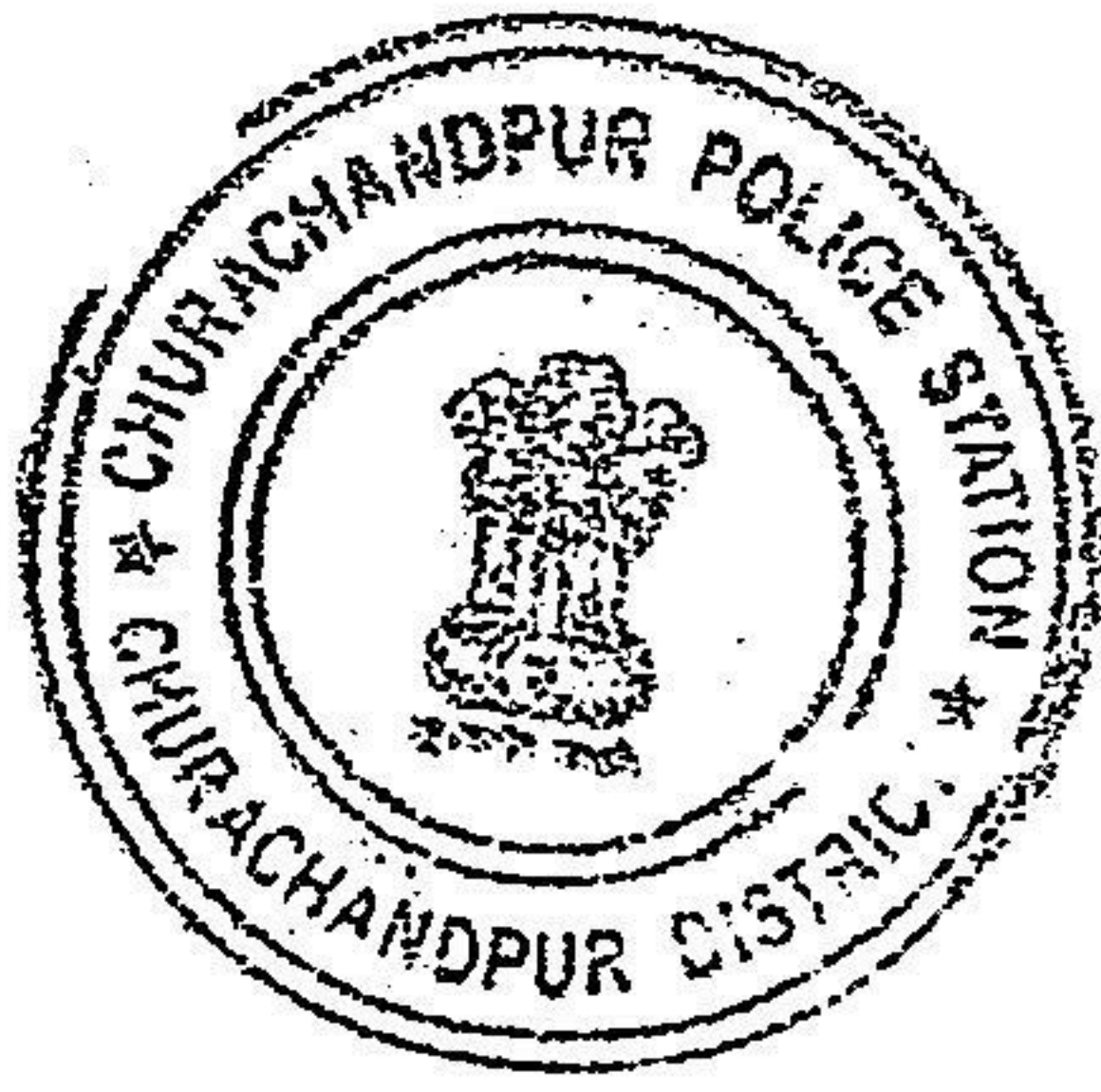

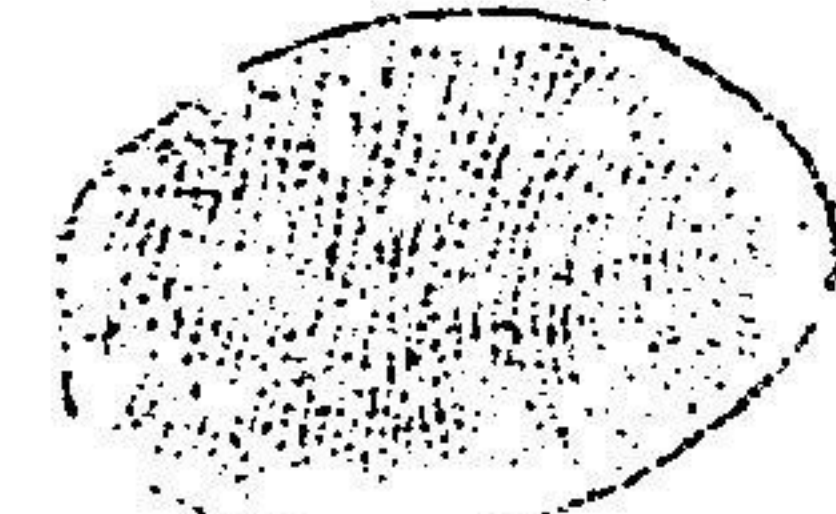
The following properties of my house were damaged in the incident.
