Subject:-

Request for taking up necessary action under Section 392, 347 of IPC against the culprits who have participated in the Tribal Solidarity March held on 03/05/2023 at Churachandpur, organized by the All Tribal Students Union, Manipur for looting / robbery of Arms & Ammunition from the Churachandpur Gun House, Tuibong Churachandpur, Manipur.

Sir,

With reference to the above subject I the undersigned proprietor of License No. Churachandpur, House, Churachandpur Gun 001/Arms(Deal)DM(CCP)2016 have to state that the following few words for taking up necessary action against the culprits who are involved in looting / robbery of huge arms and ammunition and money from my Gun House on 03/05/2023 at around 6 P.M.

That on 03/05/2023 the All Tribal Students Union (without ATSUM) organised a rally at Churachandpur. The rally was also participated by suspected armed Kuki Militants as can be seen from the video footage of the rally uploaded in the social media. At around 12.00 noon of the said day 3 (three) Forest Beat Houses in Churachandpur were also burnt down. At around 2 P.M. of the said day the participants of the rally escorted by suspected armed Kuki militants started vandalizing/burning down shops and houses at Churachandpur town and adjoining villages owned by Meiteil Meetei Community.

Apprehending, such situation may happen in my Gun House I made an application at around 5 PM to the Superintendent of Police, Churachandpur whose Office is just opposite to my Gun House for protection and safeguarding the arms and ammunition in my Gun House (True Copy of the Complaint with Typed Copy enclosed) and also informed the Officer-in-Charge of the Churachandpur Police Station telephonically. But, at around 6 PM those persons who participated in the rally and escorted by suspected armed Kuki militants entered my Gun Home by breaking down the iron doors of my Gun House and threatened my assistant at gun point and robbed the arms and ammunition from my Gun House (Video footage of breaking of my Gun House and robbing of arms and ammunition stored therein can be seen and photos enclosed herewith).

The Arms and Ammunition looted from my Gun Houses are approximately as follows:-

- Total Gun looted – 500 which includes 17 piece of Repeator, 80 pieces of Double barrel, .45 Pistol, .32 Revolver, 370 piece Single Barrel B.L. Gun, 8 pieces of .22 Rifle, 17 pieces of Ari Riffles FX, 110 Pieces of Air Riffle PX, Air Gun-PX-120 Minotaus X (PX 120A-000) and PX 120 Minotaus X3 (PX 120A-001);

- Total Ammunation – 25,000 cartidges of 12 bore, 12,000 Cartiges of .22, 3000 NPB Catridage and huge number of Pellete of Air Rifles.

Not only these arms and ammunition they have looted Rs. 25,00,000/-(Rupees twenty five lakhs) kept in the said Gun Houses. The total is about Rs.6 Cores.

My home at Khumuzamba Meitei Leikai Gun House is also burnt down by those persons participated in the said rally with those suspected Kuki Militants. Presently I along with my family are staying at the Relief Camp at Phubala. And because of the law & order situation, curfew and dislocation due to stay at Relief Camp I could not make complaint in time.

In the above stated facts and circumstances, it is, therefore, requested you to take necessary legal action against those persons who organised the rally and involved in looting / robbery from my Gun House and destruction of my house (video footage/ photos is enclosed for assistance in identifying the culprits).
