On being feared for our life, I along with my family members deserted our village on 01-06-23

The total estimated amount of all the assets that was left behind at the mercy of the above mentioned well-armed Meetei/Meitei miscreants is worth Rs 1067, 550

I, therefore kindly request you to please take action in this matter and come up with positive solution.
