



Today, i.e., 27/07/2023 at 7:00 pm, received a reliable information that when Khengmol Village was attacked and Houses were burnt down on 28/05/2023 at around 4:30 pm by unknown Meitei Miscreants of about 450 to 500 Persons, the Village Church was also burnt down including Church Guest House and one Pucca Latrine building. All the Items kept inside the Church like Benches, Tables, Chairs, Musical Instruments, four (4) Almirah (two Wooden and two Steel) and Kitchen Utensil were also burnt down.

Hence, a Suo-moto case under FIR No. 89(07)2023 SKT-PS, u/s 295/148/436/34 IPC, Sec 3(2)(iii) of SC/ST (Prevention of Atrocities) Act has been registered against the Unknown Meitei Miscreants for investigation.
