

Respected Sir,

I the undersigned beg to report for your kind and necessary action.

1. That, on 03/05/2023 at around 7:00 PM some unknown miscreants suspected to be Kuki tribes, Kuki militants and members of ATSUM stormed with arms and other incriminating weapons. They have fired and torched my residential House/Cattles/Poultry/Household items/Furniture(s)/Food items along with other valuable items located at Moneyphai Village, PS-Sangaikot, Churachandpur District.
2. That, I was staying at the said Moneyphai village since 15 years back along with my wife namely Laishram Ibemcha Devi. And the value of lost/damaged properties is around Rs. 4,46,000/- (Four Lakhs forty six thousand) approximately.
3. That, the unknown armed miscreants warned and threatened me and my family members to leave the village permanently and that we will face dire consequences if we return to our village again.
4. That, I could not report well in time due to the present law & order situation as well as I am displaced and stranded. I am taking shelter at Kakching Khunou Hijam Angom Leikai Relief camp from 28th May, 2023 till date.

It is therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki tribes, Kuki militants and members of ATSUM.
