

Rs. 47,80,000 Only.

Fortunately, me and my family managed to escaped from these criminals who
even tried to kill or burn us alive, and now currently taking refuge
at, Thingkangphai

Therefore I kindly request you to please take action in this matter and come up
with positive solution.
