

- That, on the 28 Mayat about 9:00 AM/ PM, a huge contingent of armed 2. radical Meitei/ Meetei, along with the Manipur State forces like the Manipur Police Commando, the Indian Reserved Battalion (IRB) attacked our village and in the process, they have looted, vandatized and torched my house.
- That, it may be reported here that the miscreants were shouting slogans like-3. "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO", etc. while they were carrying out their criminal activities.
- That, it may also be reported here that the above said criminal activities have caused 4. grave mental agony and incurred huge loss which may be estimated to be Rs...
