I, **Khaijakhham Simte s/o (L) Haominthang Simte** of P.Minjang, Samulamlan Block, Churachandpur, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mob.

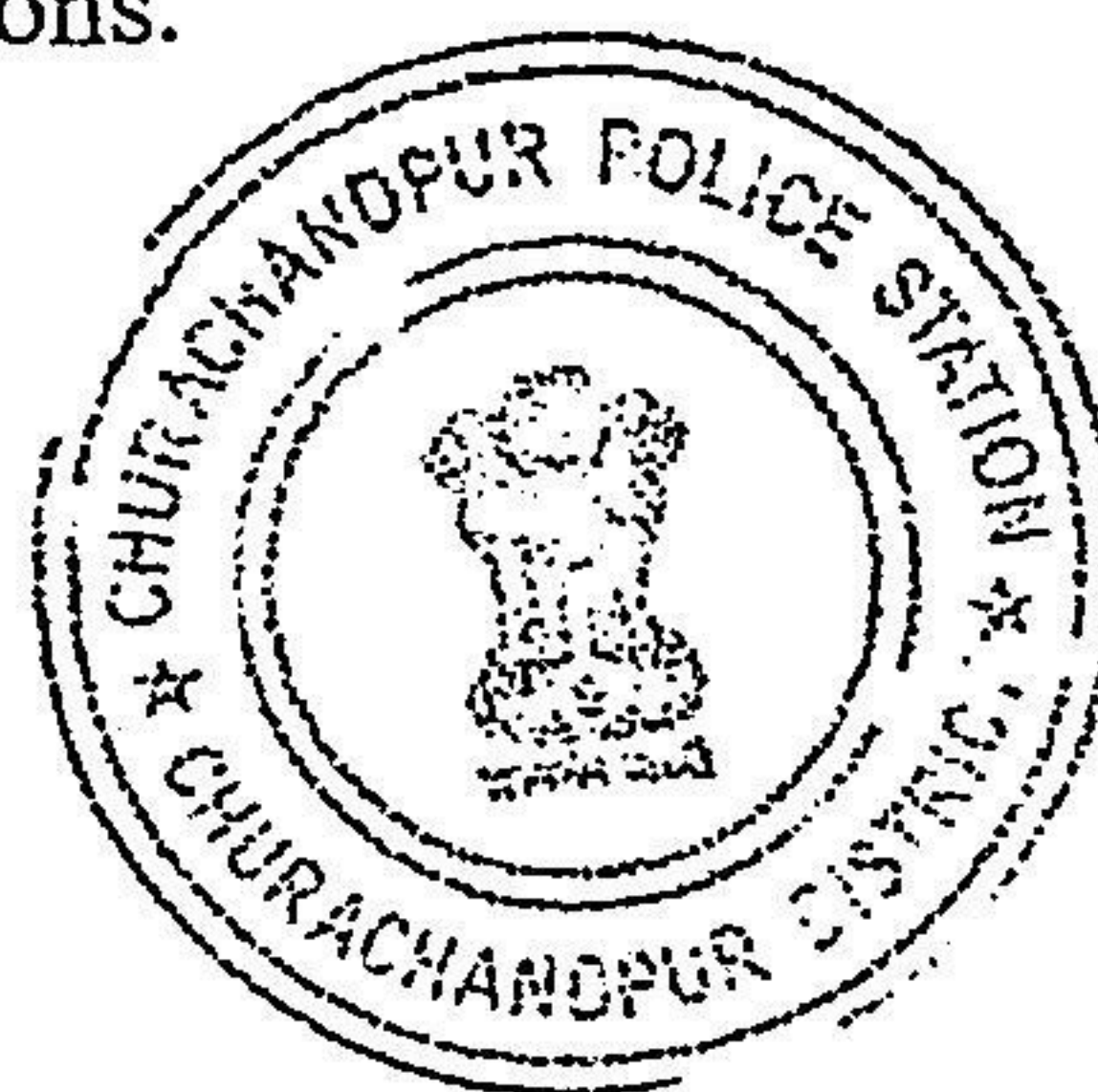
These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) Rs **18,72,800 (Eighteen Lakhs and Seventy Two Thousands and Eight Hundreds)** only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1st MR (Manipur Rifle) for our safety on the 4th May, 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
