Sir,

With due rsapect, I am the chief of Khuangmun villages, PO & PS – Churachandpur, District – Churachandpur.

That,I would like to inform and register a cognizable offenses carried out against me and my villagers in the intervening night of 3<sup>rd</sup> May, 2023 at around 10:30 Pm by Meitei Community, Who were armed with sophisticated automatic guns like AK's, Rifles, Pistol, Machette and knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs.

Due to such attacked carried out against my village and villager, as such being in vulnerable state. I and my family along with villagers numbering male-21 and Female-30 had fled from our village fearing to lose our life.

As such, we have been taking shelter at relief camp at Ideal High School, Cannan Veng, Churachanpur District.

On inquiry, 24 (Twenty four) household were ransacked, torched and burned. Domestic animals were killed and taken away; properties were looted and taken away rendering my village at helm.

Therefore, I seek your kind intervention to register an FIR against me and my villagers for the end of justice.
