Subject: Report against Arson attack of moveable and immovable properties that took place on 4th May, 2023 at about 8:00 pm at Lailampat, P.O. & P.S. Churachandpur.

Sir,

I, the undersigned, a victim have the honour to state the following for your kind intervention and favourable action that, on 4th May 2023 at around 8:000 pm, unknown mobs from the Meitei community armed with deadly sophisticated weapons came and forcefully vandalized and looted our house, thereby burning our residential house, the description of which is detailed hereunder:-

- (1) Immovable property Kutcha House
- (2) Moveable property (i) All the goods inside the house along with Granary house and livestock cattle's.

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 14,00,000/- (Rupees Fourteen Lakhs) only.

Being the victim, I am filing this report and therefore request you to kindly take necessary legal action against the said culprits as per law.
