Subject:- Report on sustaining of bullet injury.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

- 1. That, I Shri. Liangoumang S/o Ginkhanmung, aged about 22 years, belonging to the Paite tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, at about 07:30 pm on the 3<sup>rd</sup> of May 2023, I was caught in an indiscriminate fire shot by meetei/meitei armed personnel spearheaded by Meetei/Meitei Leepun aided by various valley based state Forces at Kangvai Village, Churachandpur District, during which I sustained a bullet injury on my left palm leaving me unable to lead a normal life, fortunately survive the ordeal, however due to undergoing medical treatment and ignorance of the relevance provision of law there has been delayed in filing a complaint of the incident.
- 3. That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by Arambai Tengol and Meetei Leepun aided state forces, I am filing this with a request to kindly take necessary legal action against the perpetrators as per law.
