

Subject: Report against criminal intimidation, vandalism and arson attack on Evangelical Churches Association and all its properties that took place on 3<sup>rd</sup> May, 2023 at around 8:00 PM at Leiriphai Village, within Churachandpur - PS.

Sir,

I, the undersigned, on behalf of the Evangelical Churches Association have the honour to state the following for your kind intervention and favourable action that, on 3<sup>rd</sup> May 2023, at around 8:00 PM, our said Church building (with all the church properties inside) located at Leiriphai Village was attacked, vandalized, completely destroyed and burned down to ashes, by heavily armed unknown miscreants/ goons from the Meitei community. The estimated value of all the moveable and immovable property destroyed, vandalized and burnt is estimated to be worth approximately Rs. 10,00,000/- (Rupees Ten Lakh) only.

That, as all the said Meitei goons/ miscreants are roaming around openly armed with deadly weapons, all the Church members ran in fear of their life, and they being displaced, I in the capacity of the Executive Director of the said Church, file this report at the nearest Police Station and therefore, request you to kindly take necessary legal action against the said culprits as per law.
