Subject- Report on looting of household properties

Respected Sir,

With the prevailing riot and unrest situation of Manipur, I am writing to report the incidence of looting and theft that occurred since the start of communal violence i.e. 3 rd May, 2023. While I was taking shelter at IGAR(S) campus, Imphal, my aged parents alongwith my siblings who were residing in my residence at Torbung village, Churachandpur (Torbung being one of the epicenter of the violence) had to fled to a relative place in Lamka, Churachandpur, abandoning the house. Later it was known that some unknown miscreants have forcibly entered my residence by breaking the lock and keys of my residence and had looted & vandalized my properties.

The detail assessment of Goods & Properties abandoned / vandalized/ looted at above mentioned address are as under :-

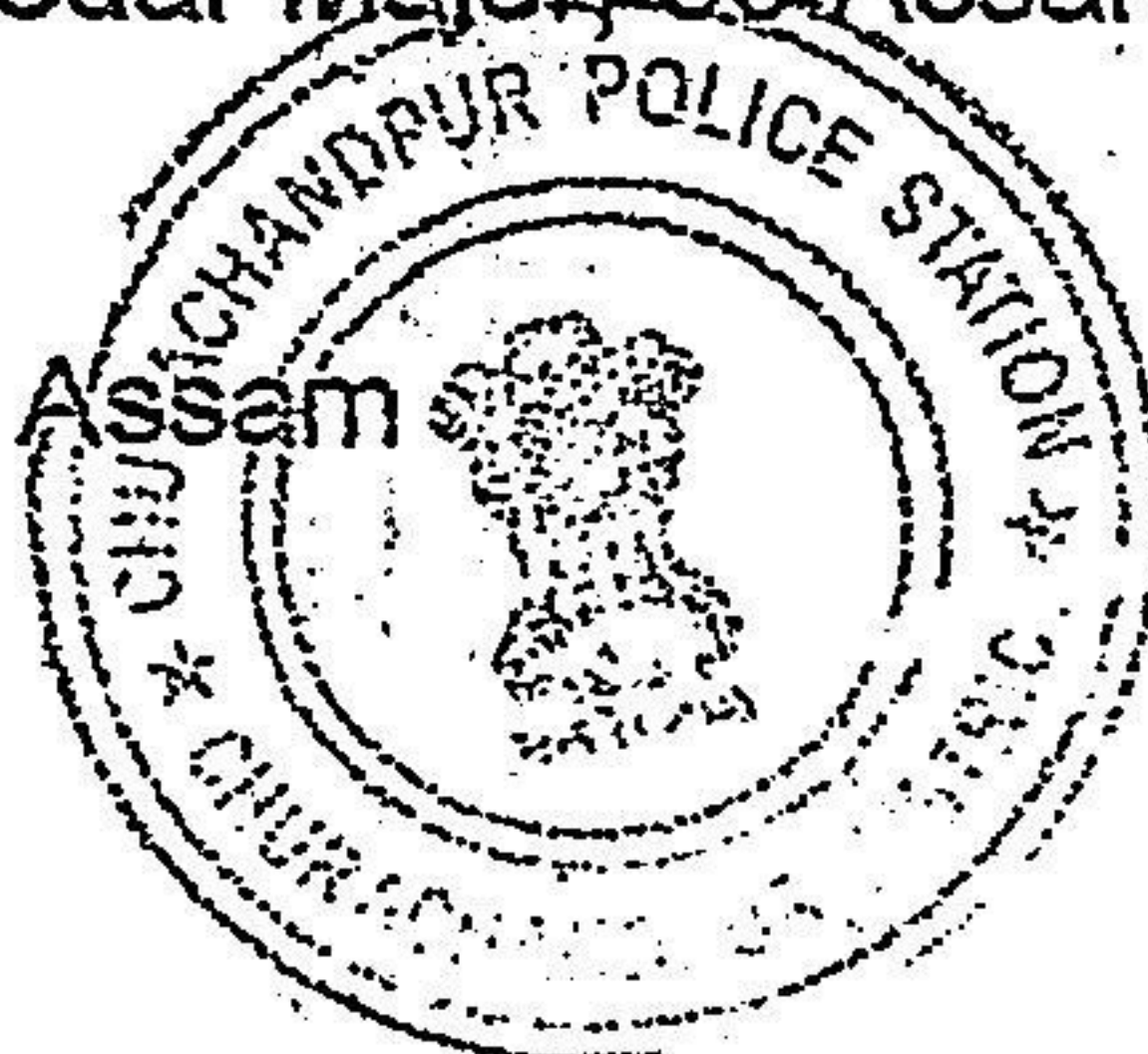
