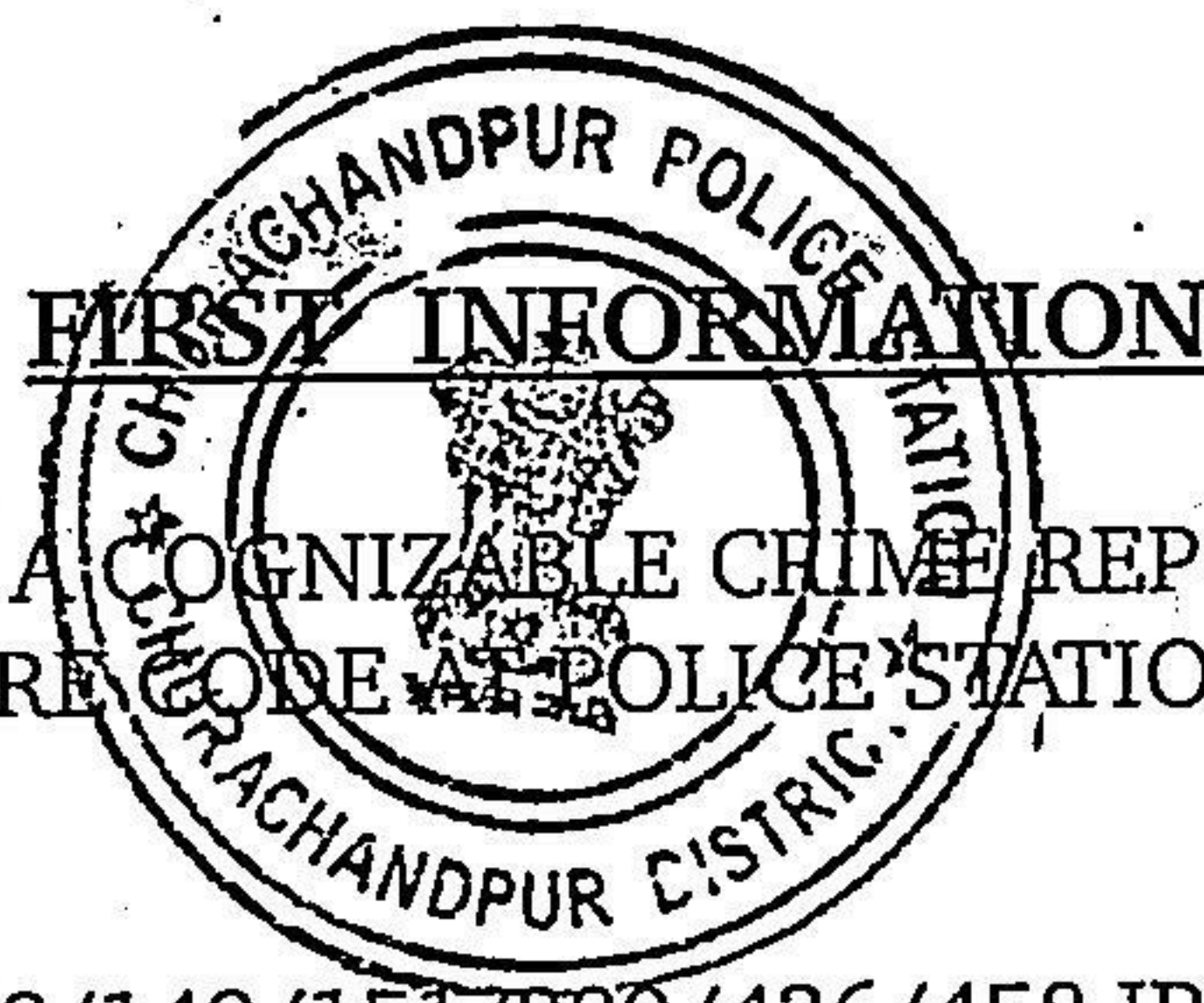

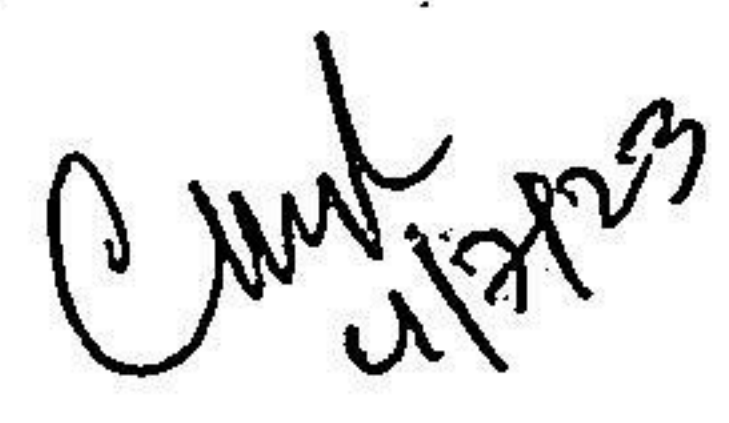

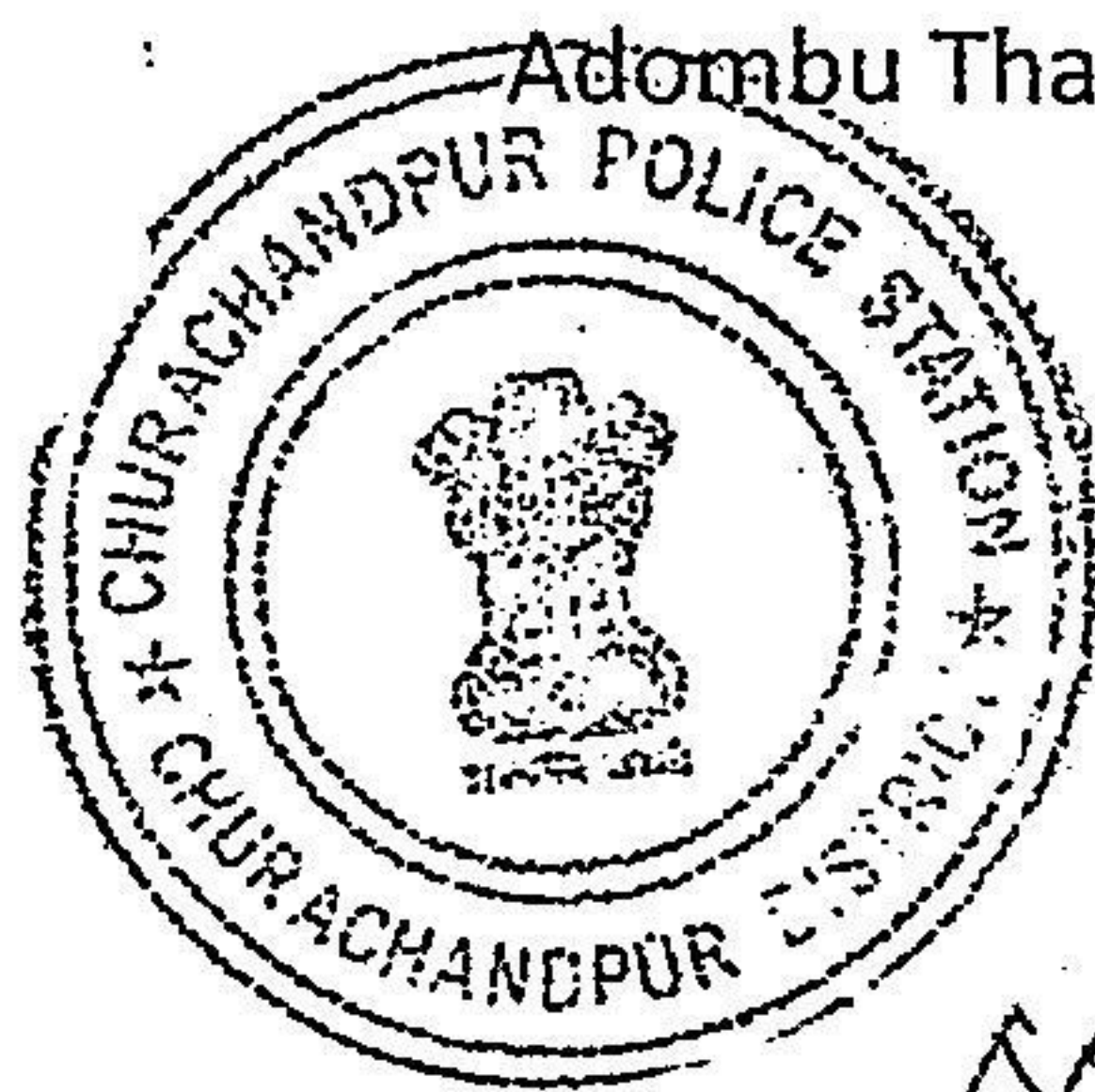
Respected sir,

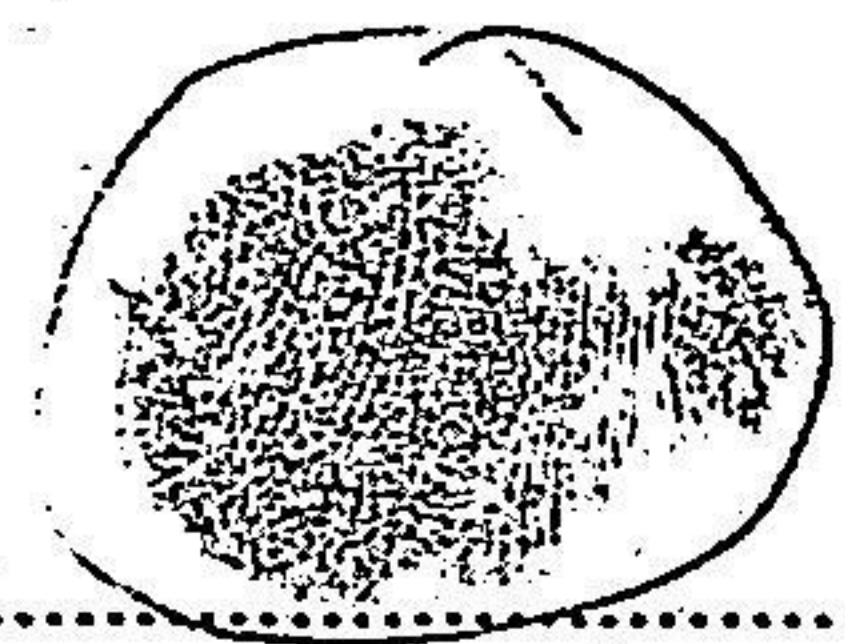
