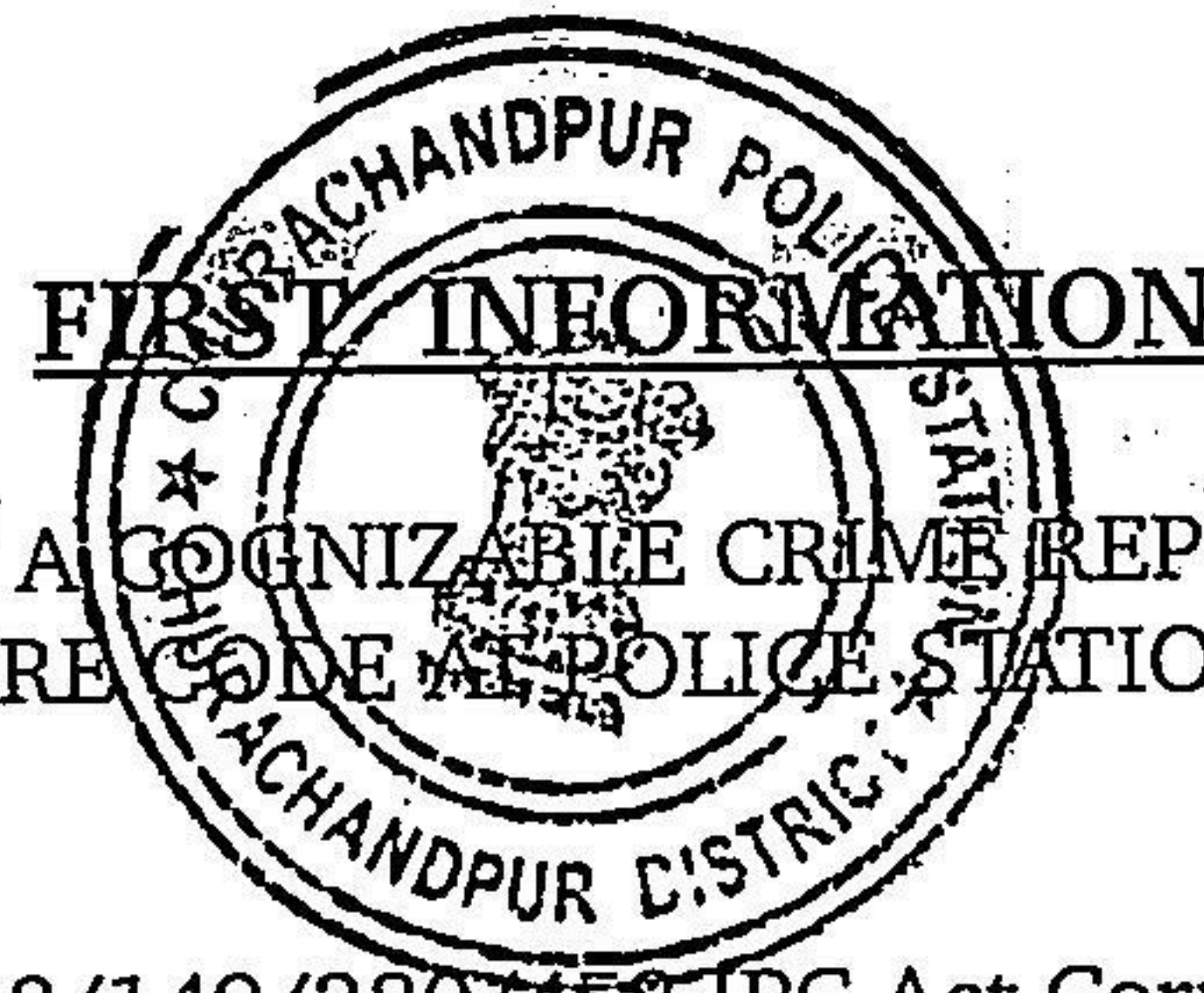

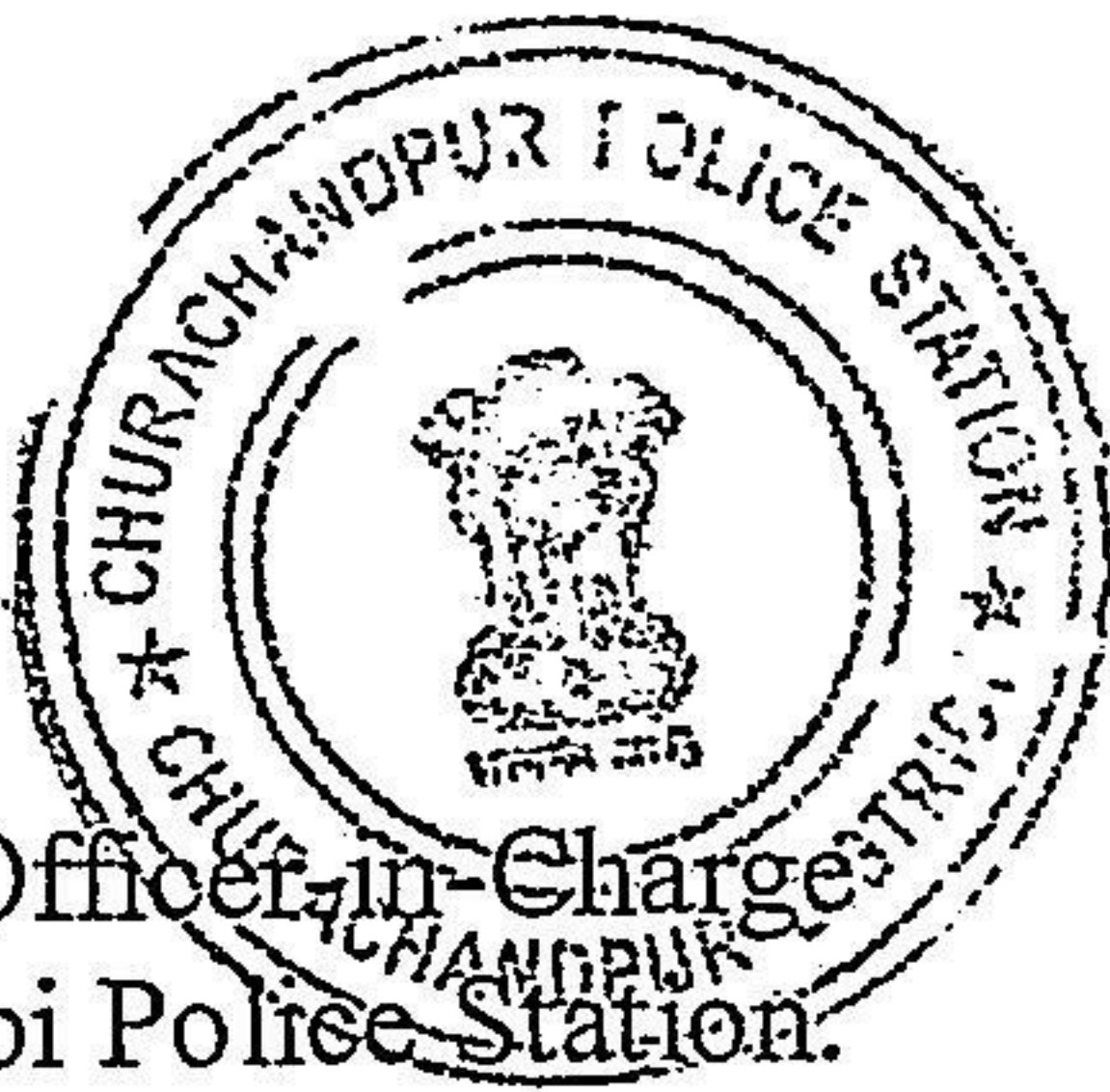

We the undersigned have the honour to report that on 04/05/2023 at @ 10:00 am some kuki miscreants have trespassed to our Model Tailor House which is located at Tipaimuk Road Churachandpur and started vandalised our properties. Further they had stolen/robbed away all the properties inside the tailor house. The following properties have been robbed by the miscreants:-

- 1) Properties stolen for complainant no.1 - i) 120 nos. of 500 rupees currency note i.e Rs.60,000/- (Sixty Thousand) only. ii) Honda Activa bearing registration number MN01Z 6698 Black in colour, worth Rs. 60,000/- (Sixty Thousand) only. iii) Cloths, Utensils, gas stove, cylinder and others worth Rs. 15,000/- (Fifteen Thousand) only. Total approximate value is Rs.1,35,000/- (One Lakh and Thirty Five Thousand) only.
- 2) Properties stolen for complainant no.2 - i) Cloths, utensils and bills of works worth Rs.60,000/- (Sixty Thousand) only.
- 3). Properties stolen for complainant no.3 - i) Cloths, utensil and daily wages bills of works worth Rs.60,000/- (Sixty Thousand) only.

So, therefore requested you to kindly take up necessary legal action against the culprits.
