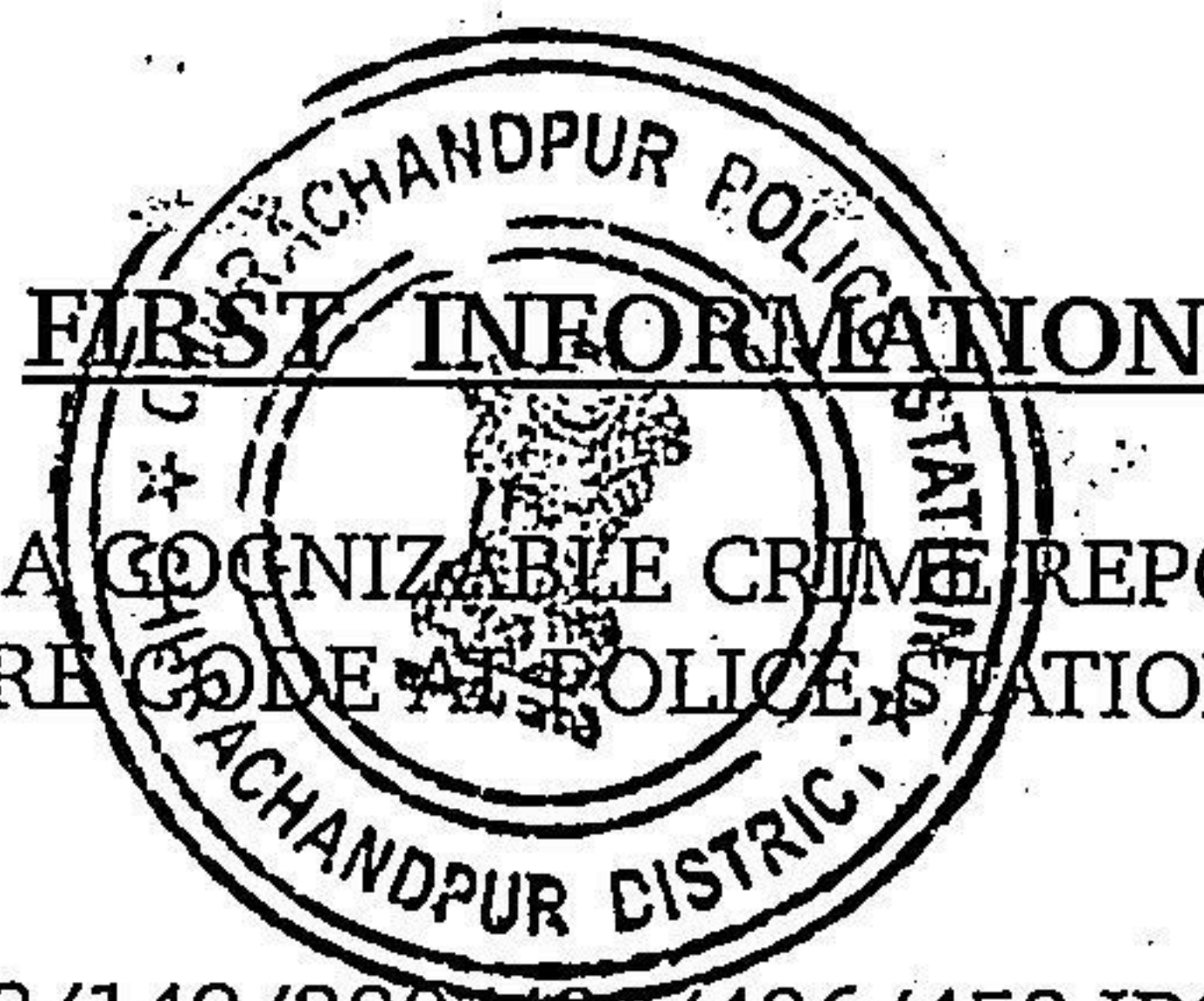

Dear Sir,

With due respect, I, the undersigned, have the honour
to state that I am a permanent resident of Zoveng Khuga Tampak
but now displaced by the recent Kuki Mob happened on the 3rd Ma
2023^{at @ 9:00 PM} and staying at the relief camp at Kumbi Central High
School, Kumbi. Further to inform you that my house at
Zoveng Khuga Tampak has been burnt down by some gun totin
Kuki whom I believe to be Kuki Militants who are under
suspension of operation with the Union and State Government. And,
my properties worth roughly Rs. 50,00,000.00/- Lakh have been
looted by them and their other unarmed associates. The details
of my destroyed and looted properties are enclosed herewith
a table. I, therefore, request you to kindly investigate and take
up necessary legal action(s) against those criminals and restore
my lost Land and Properties to me.

Condition upon the current clash between Kuki and Meite
community, you are heart fully requested to pardon me for my
failure to report the same to the concerned Police Station in
time. Thanking for your anticipation and your kind
consideration and prompt action
