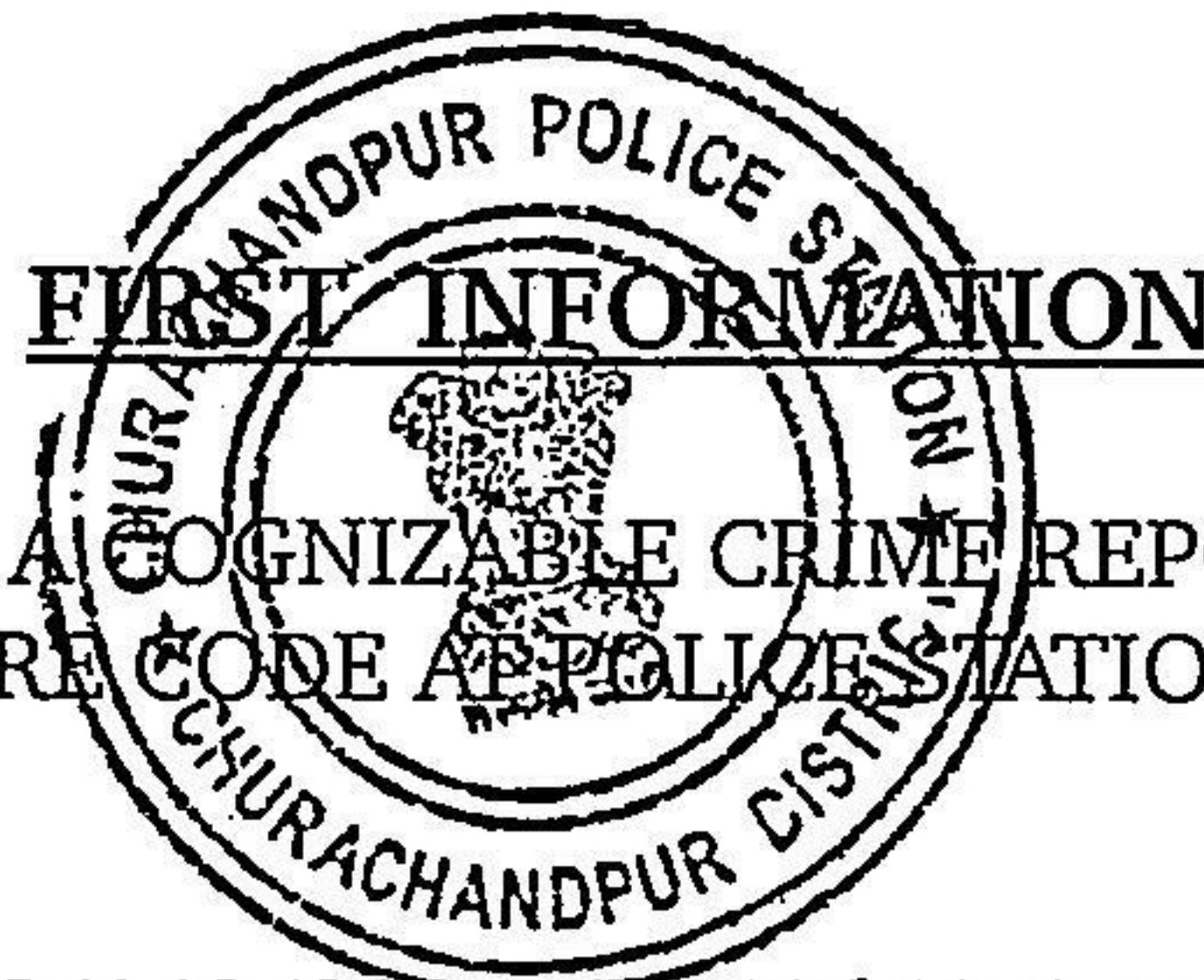

Dear sir, With due respect, I the undersigned, have the honor

to state that I am a permanent resident of
Thing Kangphai village C.C. pur. But now displaced
by the recent Kuki mob happened on the 31st May 2
at 6:00 pm staying at the relief camp at Kumbi central H
School. Kumbi. Further, to inform you that my house
at Thing Kangphai village C.C. pur has been burnt down
by some gun totting Kuki whom I believe to be Kuki
militants who are under suspension of operation with
the Union and State Government. And my properties
worth roughly Rs. 38,15,000 Lakhs have been looted
by them and their other unnamed associates. The details
of my destroyed and looted properties are enclosed.
I therefore, request you to kindly investigate and take up
necessary legal action against those criminals and restore me
lost land and properties to me.

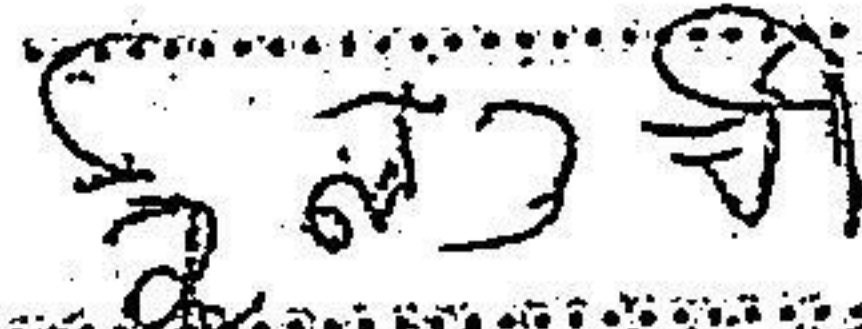
