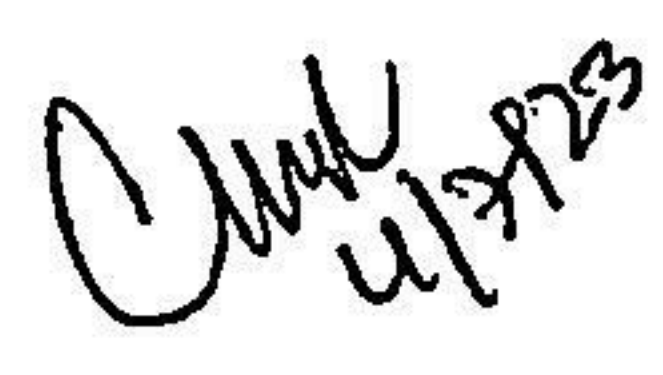

I, undersigned beg to report for your kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.

2. That, on 03/05/2023 at around 11:30 pm. While I was at rented house along with family members, some armed Kuki militants attacked my business properties including stock items for sale and shop building and destroyed the aforementioned worth around Rs. 54,28,000/- approximately.

3. That, the said Kuki armed militants also set on fire and burnt down my shop building along with all business items, and everything related to the functioning of my said business.

In view of the facts and circumstances, I shall be very grateful if you would kindly initiate appropriate steps for identifying the Kuki armed militants apprehend them and punish them in accordance
