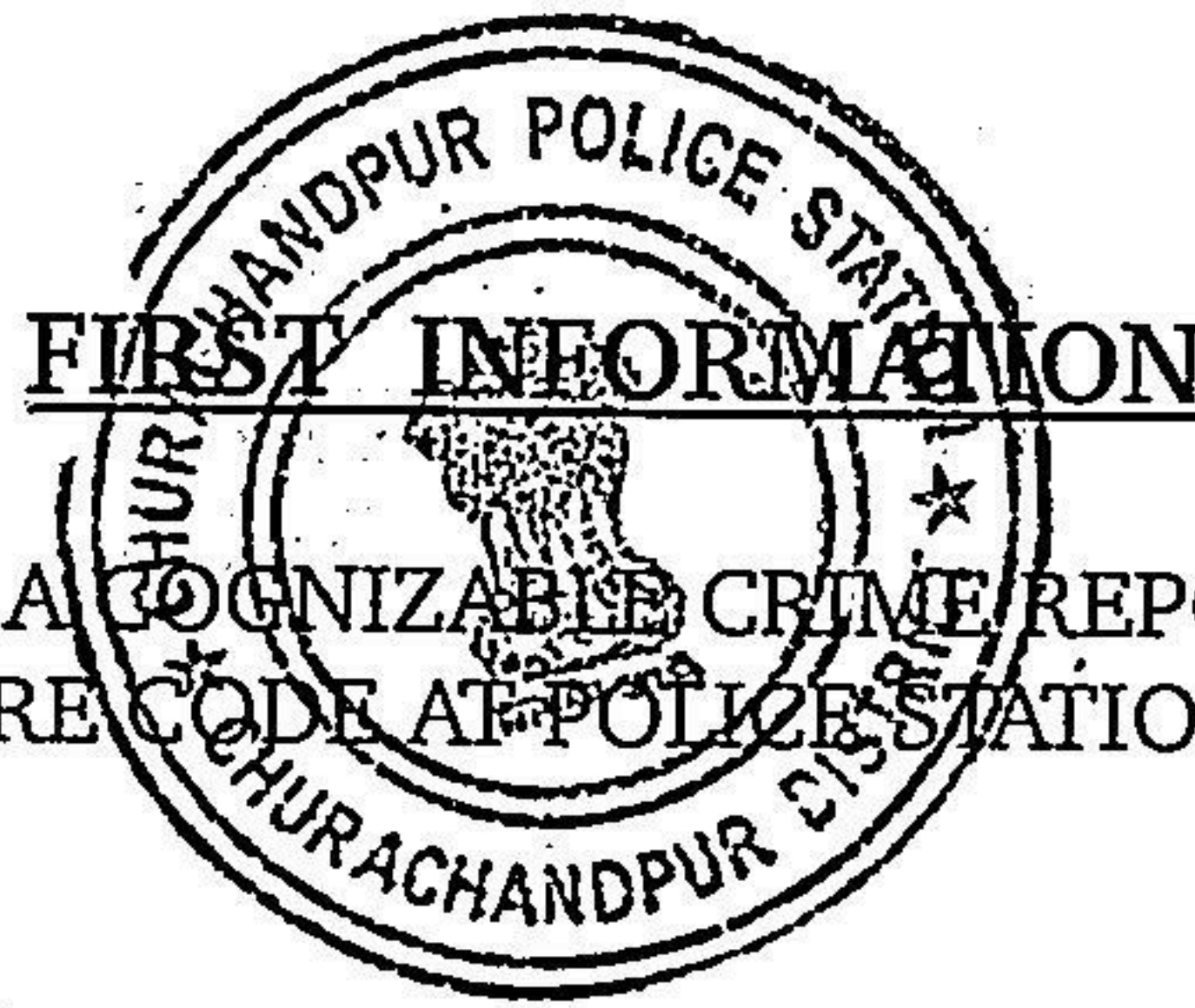

Subject: Report

Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.
2. That, On 03/05/2023 at around 11:30pm while I was at home along with my family members, consisting of myself, Wife children and other family members, some Kuki armed militants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 10,66,000/- approximately.
3. That the Kuki armed militants conversed among themselves in the Kuki dialect while firing and physically assaulting my family and destroying my household properties. The said Kuki armed militants also set on fire and burned down my residential house and other household items which are given in the list enclosed along with this report.
4. That, the Kuki armed militants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village. Delay of filing FIR is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if yourself would kindly initiate appropriate steps for identifying the Kuki armed militants apprehend them and punish them in accordance with law.

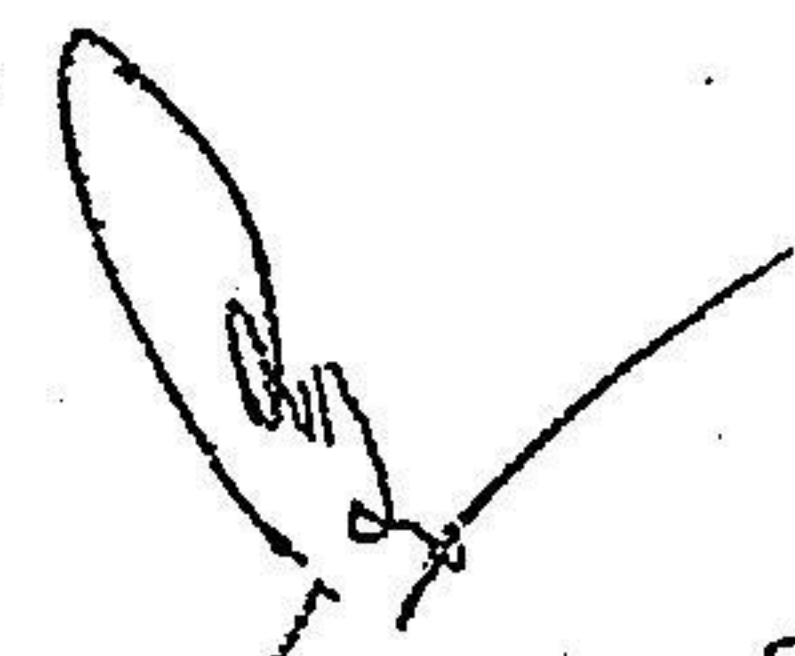

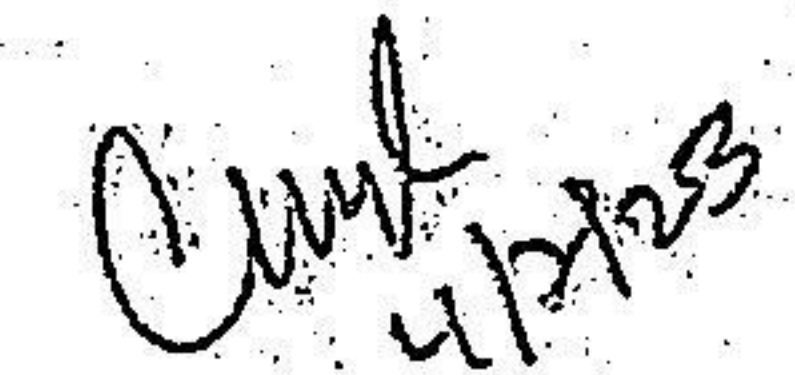
