Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

- 1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.
- 2. That, on 3rd May,2023 at around 10:30 pm. While I was at home along with my family members consisting of myself, my wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed properties (household) worth around Rs. 42,64,340/- (Rupees forty two Lakh sixtyfour thousand and three hundred forty only) approx.
- 3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown arm miscreants also set on fire and burned down my residential house and important documents and other household items which are given in the list enclosed along with this report. Further unknown arm miscreants had forcibly snatched my TATA Harrier car bearing reg. No. MN01AW0042, Engine No.46343885-4094889 & Chassis No. MAT631538MPB5477, which was parked at my residential garrage.
- 4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing FIR is due to displacement and uncertainty of relief place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
