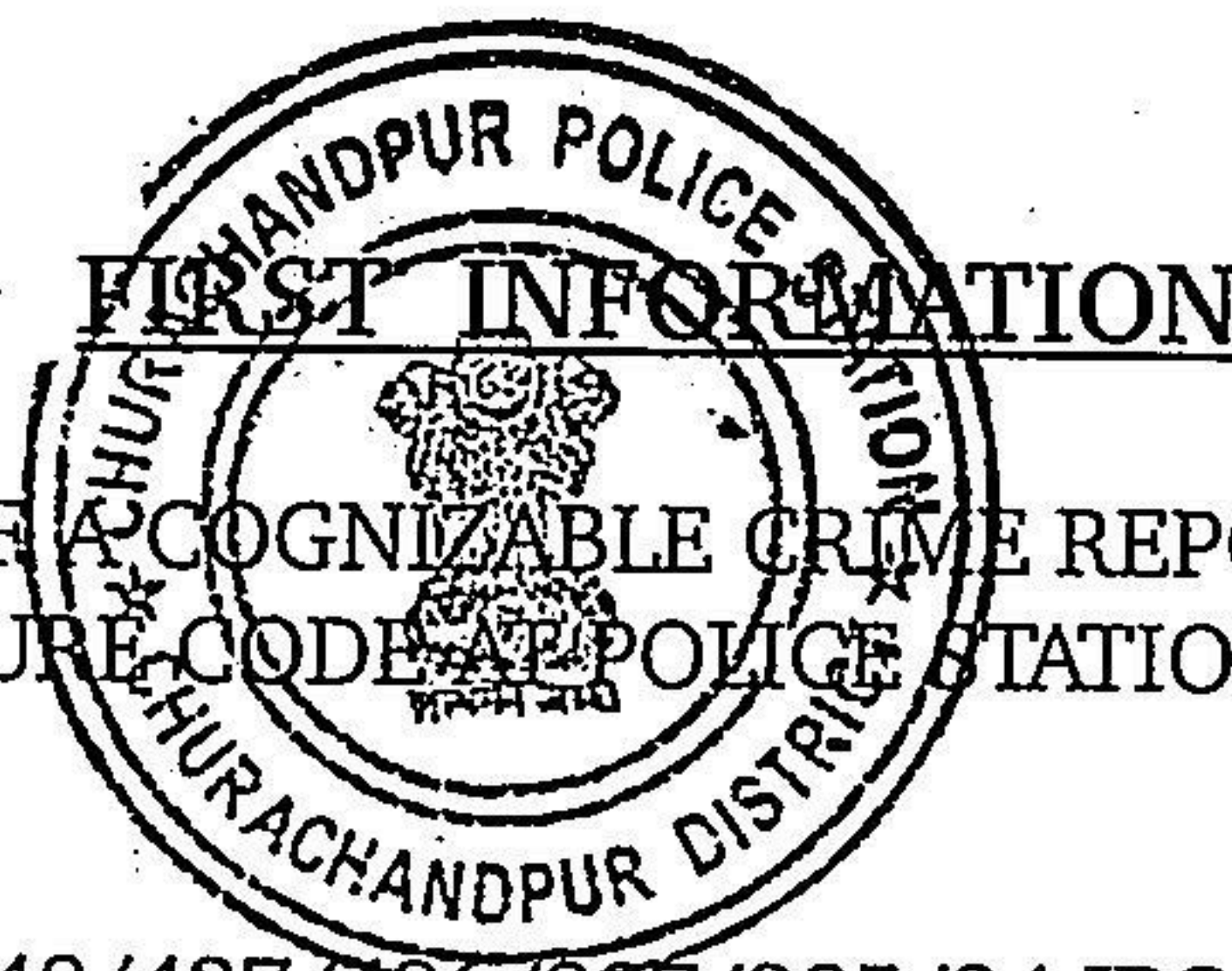

Therefore, with utmost respect, I request you to take strong actions against the Perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
