Respected Sir,

I, the undersigned beg to report for your kind and necessary action
Officer-In-Charge
Churachandpur Police Station
Manipur

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.
2. That, on 3rd May at around 10.30 a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 15,20,900 (Rupees fifteen lacs twenty thousand nine hundred approximately).
3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house, and carport and documents private vehicle and other household items which are given in the list enclosed along with this report.
4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Stay of filing of FIR is due to displacement and uncertainty of relief camp/place. In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

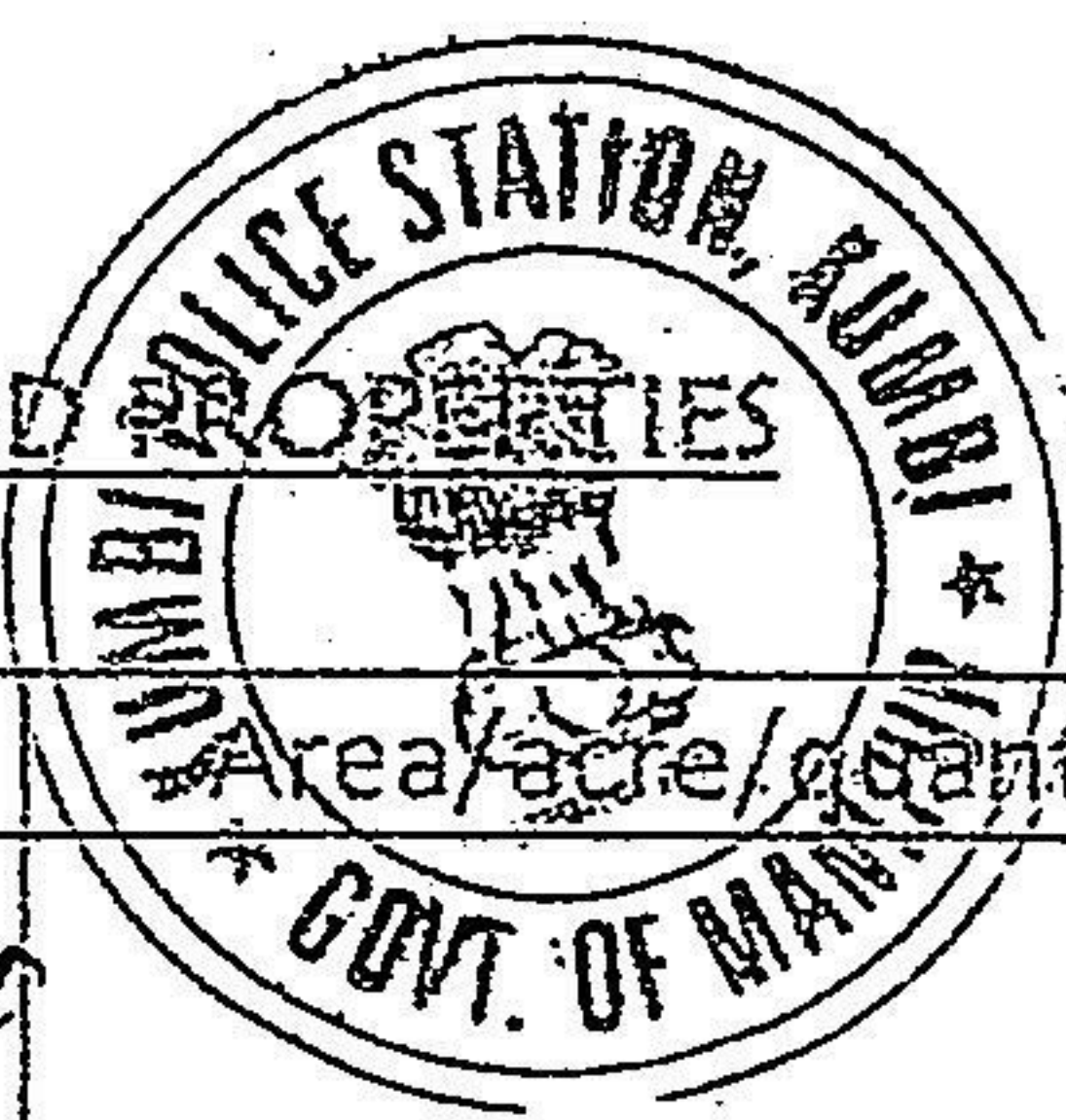
