Sir,

With due respect, I would like to report that I along with my family member were staying at a rented house of Mr. Leimapokpam Ibobi Singh of Zoveng Meitei Leikai, Churachandpur since 5 years ago. On 4th May, 2023 at around 4:00 pm a large number of unruly mob rioters numbering around 300/400 with arm & deadly weapon suspected to be Kuki tribes & Kuki militants had turn into violent and started vandalizing and burnt down my rented houses into ashes. The following properties were vandalized and burnt down in the incident:
