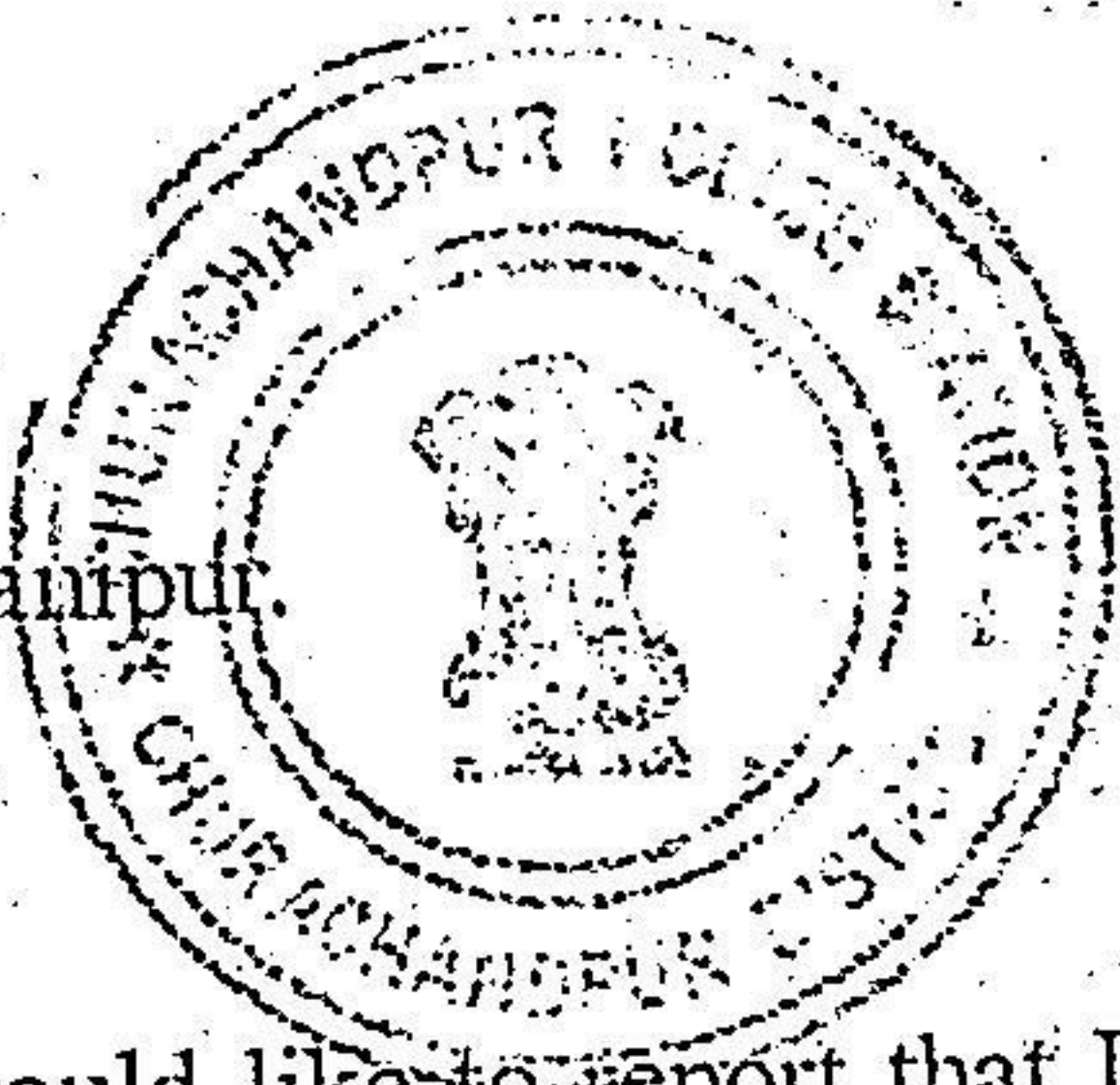

With due respect, I would like to report that I along with my family member were residing at a rented house located at Tuibong Bazar near Forest Gate, Churchandpur since the last 20 years ago by running a shop and the said rent house with shop is rented by Mr. Kc. Mangkholen S/O Kc. Chonseil of Tuibong. On 3rd May, 2023 at around 8:00 pm a large number of unruly mob rioters numbering around 300/400 suspected to be Kuki tribes & Kuki militants with deadly weapons and sophisticated arms and stormed my rented house. The said group have vandalised/burnt down my rented house and looted all valuable items / shop items listed below. Further they had stolen away my Honda Activa 125 black in colour bearing regd. No. MN06SH0400 which was parked at my rented house.
