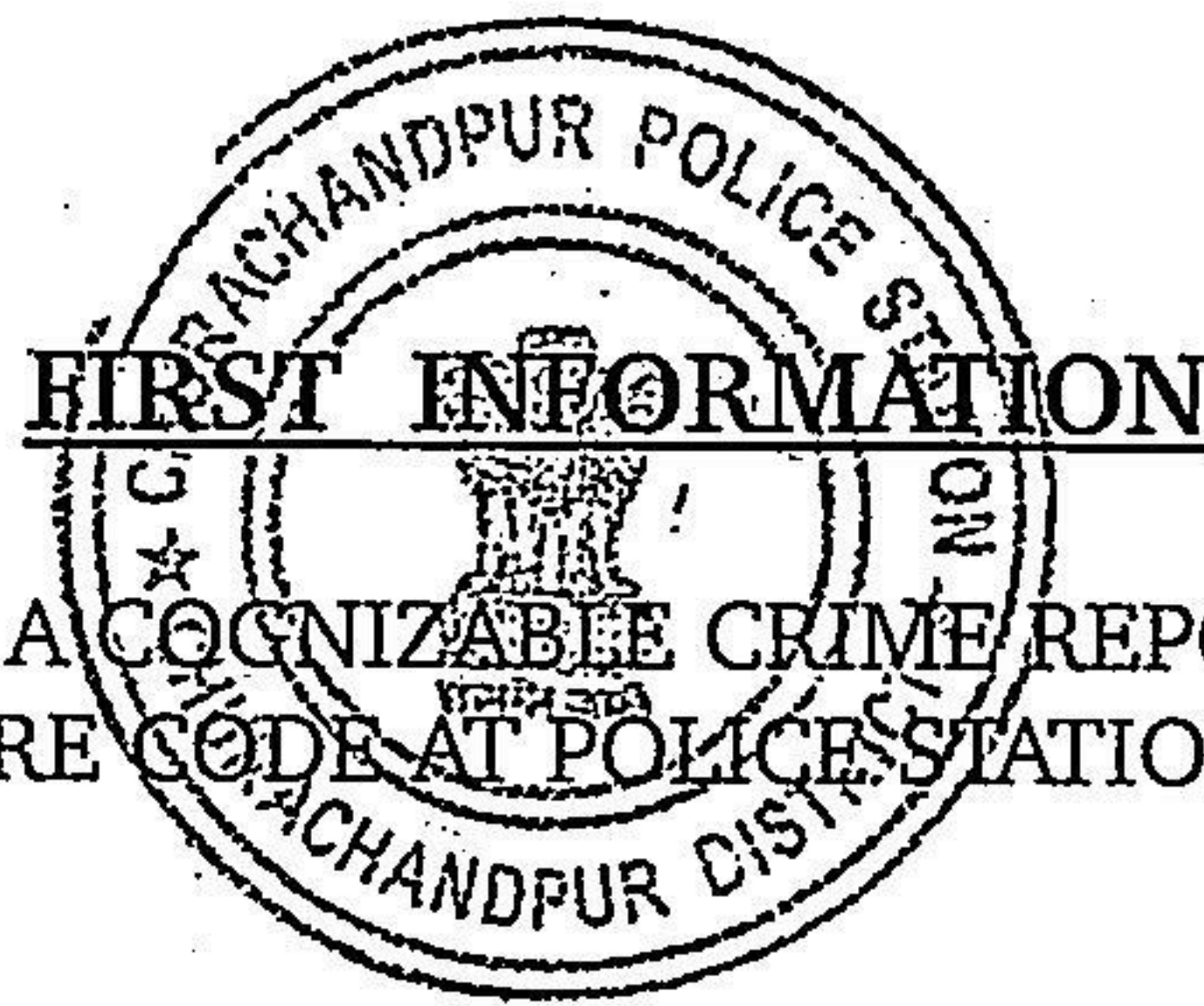

Subject- Request to register a complaint recent attack upon me and my Villagers.

Sir,

With due respect, I am the chief (Chairman) of Gotengphai
PS. C Cpur, District C Cpur, Assembly Constituency 59 Saikot
Polling Station 59/30 - Dapkon

That, I would like to inform and register a cognizable offenses carried out against me and my villagers on 30th May, 2023 at around 10 P.M. by Meitei Community, Who were armed with sophisticated automatic guns like AK's, Rifles, Pistol, Machete and knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs.

Due to such attacked carried out against my village and villagers, burnt down the whole villages and livestock, as such being in state of vulnerability. I and my family along with villagers numbering male 31 and Female 37 had fled from our village fearing to lose our life.

As such, we have been taking shelter at various places in an around Churachandpur, such as Relief camp of Idaol School. Some take refuge to near ones and relatives at B. Phaiam, Sangja, P. V. K. and around Tuibong Churachandpur.

On inquiry, 20 household along with Public Water pump (Looted)
Water pipe (Looted) 20 Feet (250 pieces) were
ransacked, torched and burned down to ground. Domestic animals were killed and taken away; properties were looted and taken away rendering my village at helm. Total Assets: 9 Lakhs

Therefore, I seek your kind intervention to register an FIR against the perpetrator and abettor who commit such heinous act upon me and my villagers for the end of justice.
