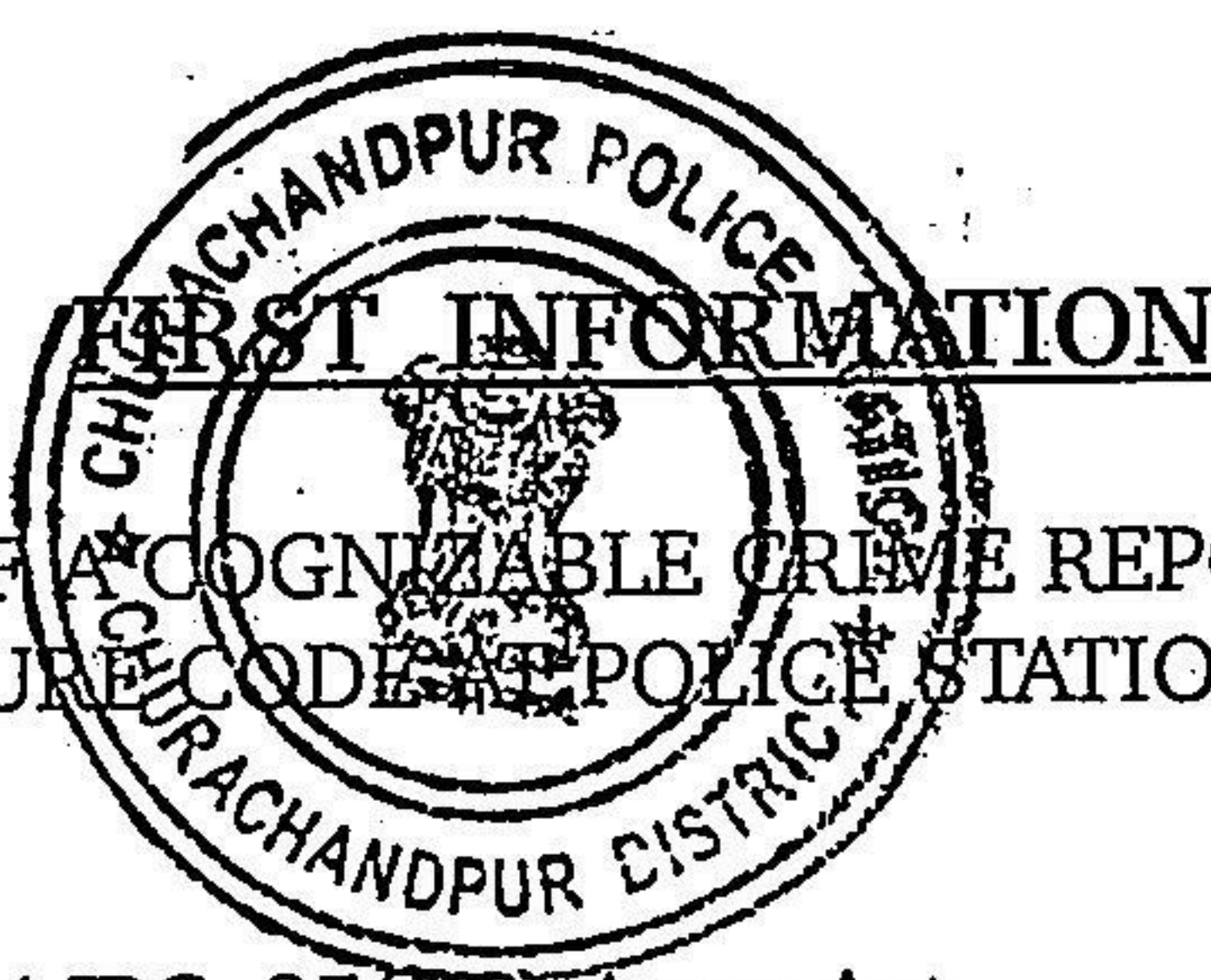




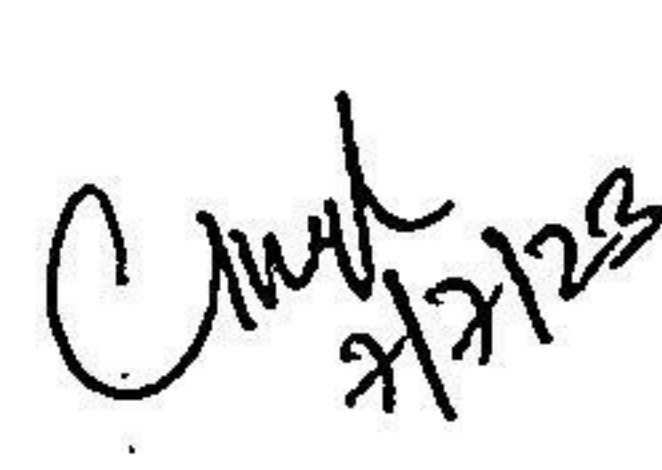

Subject: - Report against the killing of

- (i) Mr. Sokhongam Baite (21 years), S/o Doukhanthang Baite, a resident of B. Khonom Village, P.O., P.S. & District- Churachandpur, Manipur; and
- (ii) Mr. Hengoumang Lhungdim (20 years), S/o Letkholun Lhungdim, a resident of Old Gelmol Village, P.O., P.S. & District- Churachandpur, Manipur.

Respected Sir,

With great grief and concern, I have the honour to make this first information report (FIR) to you regarding the unfortunate incident of shooting and killing of the above named victims, which I do as under:

1. That, I am the elder brother of the above named victim No.(i) *Sokhongam Baite*. We belong to the Vaiphei Tribe, a Scheduled Tribe under the Constitution of India, and we are residents of the address mentioned above.

2. That, on the 6th of July, 2023 at about 2:30 PM, my above named brother and victim was called for village duty as volunteers at Phuisanphai Village. And, at the time of carrying on volunteer duty of guarding the village from the attack of the majority community Meiteis, my Brother was unfortunately shot at the head and the victim No.(ii) mentioned above, Hengoumang Lhungdim, was hit on his arm and the bullet exited on the other side. They both unfortunately succumbed to the bullet injuries.

3. That, the dead bodies of my brother and his friend are taken and kept at the Churachandpur District Hospital Morgue at about 4:00 AM of the 7th July, 2023.

I, therefore, request you to kindly register my report and investigate the matter; arrest the culprits involved in the gruesome act and book them under relevant sections of the law of our country. And, for this act of kindness, I shall always remain thankful to you and obliged.
