Sir,

With due respect, I have the honour to state that my residential house having 07 (Seven) Rooms excluding Verandah which is located at Bijang Khunou Meitei Leikai Opposite Kamdou Veng Road has been destroyed/ broken and stolen away all the properties from the said houses after destroying since the last 03/05/2023 till now by unknown miscreant and then, they are still trying again to destroy the houses by using Backhoe (JCB). In this incident, I have lost my properties approximately amount of Rs. 1,10,00,000/- (Rs. One Crore Ten Lakhs) only, without the land value.

It is, therefore, earnestly requested that necessary legal action may kindly be taken against the culprits.
