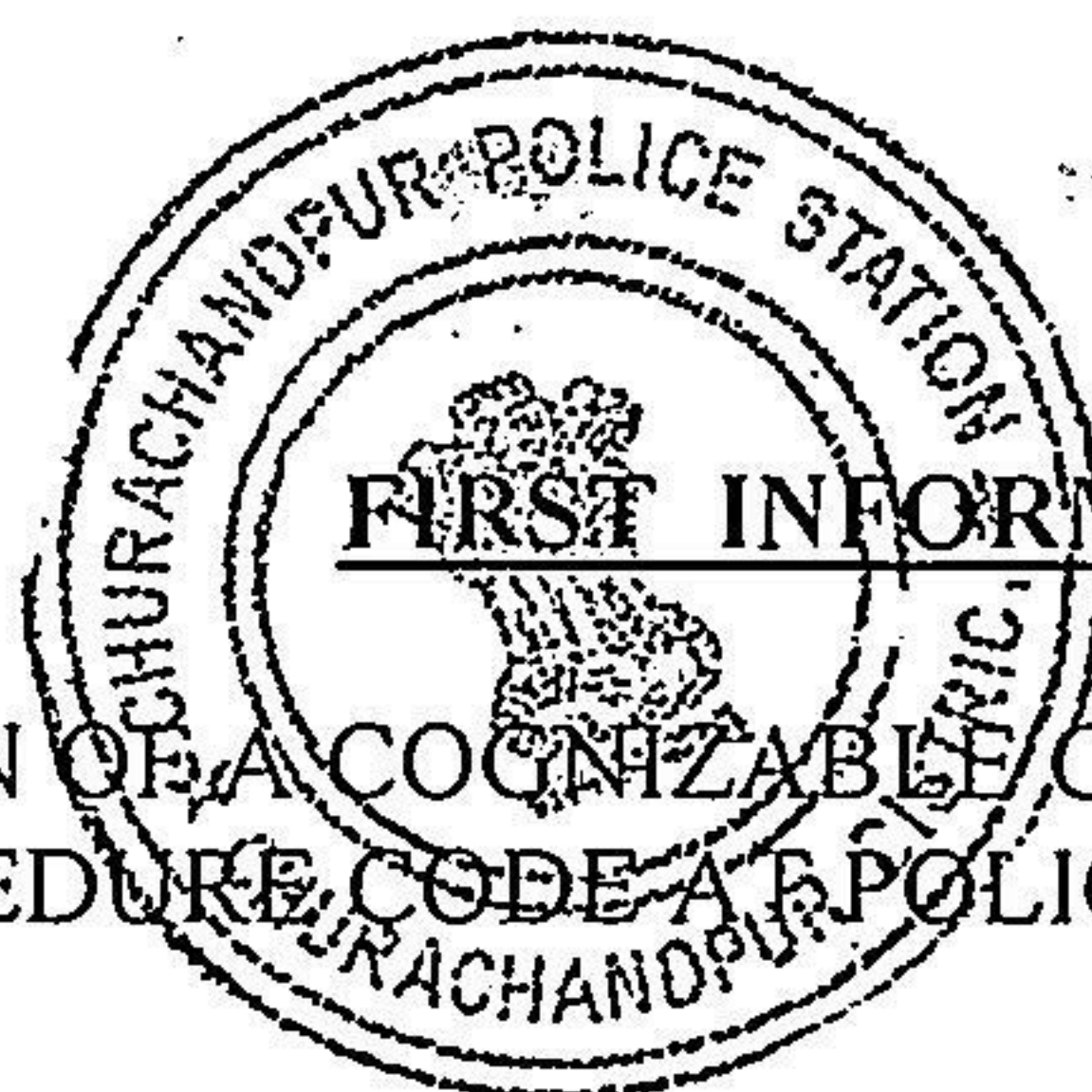

Sir,

With due respect, I have the honour to state that my plot having 03 (Three) Blocks running Grocery Shops by Businessmen and 03(Three) houses occupied by civil persons on rental basis which are located at Bijang Khunou Meitei Leikai Opposite KARAOKE Building along the Tiddim Road have been destroyed/ broken and stolen away all the properties from the said houses after destroying since the last 03/05/2023 till now by unknown miscreant and then, they are still trying again to destroy the houses by using Backhoe (JCB). In this incident, I have lost my properties approximately amount of Rs. 1,50,00,000/- (Rs. One Crore Fifty Lakhs) only, without the land value.

It is, therefore, earnestly requested that necessary legal action may kindly be taken against the culprits.
