





Sir,

With due respect, I have the honour to state that my residential Paka Cemented Building having 04 (Four) Rooms excluding Verandah which is located at Bijang Khunou, Meitei Leikai near Forest Gate has been destroyed/ broken and stolen away all the properties from the said houses after destroying since the last 03/05/2023 till now by unknown miscreant and then, they are still trying again to destroy the houses by using Backhoe (JCB). In this incident, I have lost my properties approximately amount of Rs. 60,00,000/- (Rs. Sixty Lakhs) only, without the land value.

It is, therefore, earnestly requested that necessary legal action may kindly be taken against the culprits.
