from my "Owned / Rental" House, and premises worth Rupees ... 3,15,000 ...  
and they burnt down all the remaining things.

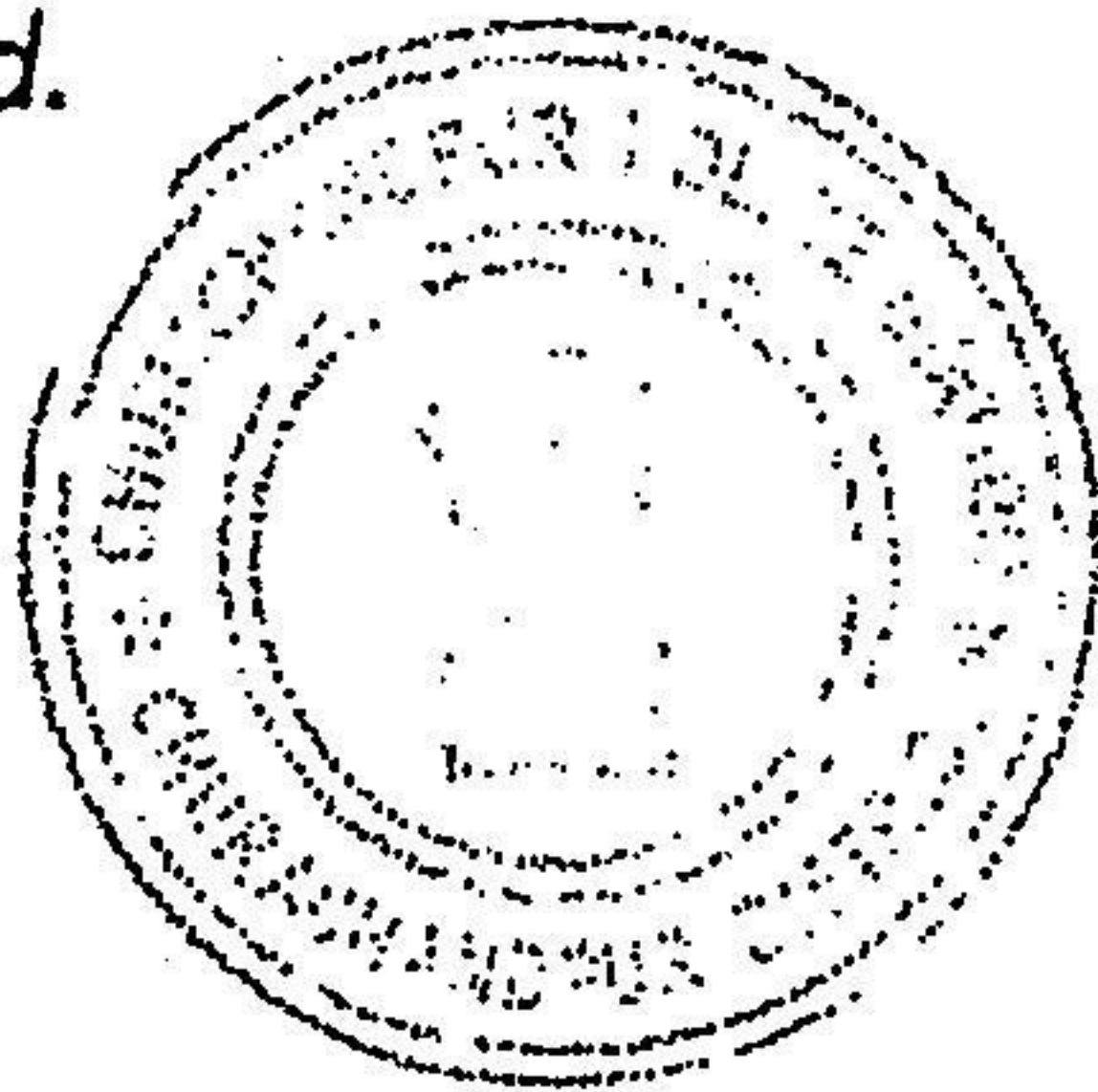
That, while carrying out their above said criminal activities, the said Meitei radicals  
were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANG  
YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family

registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
