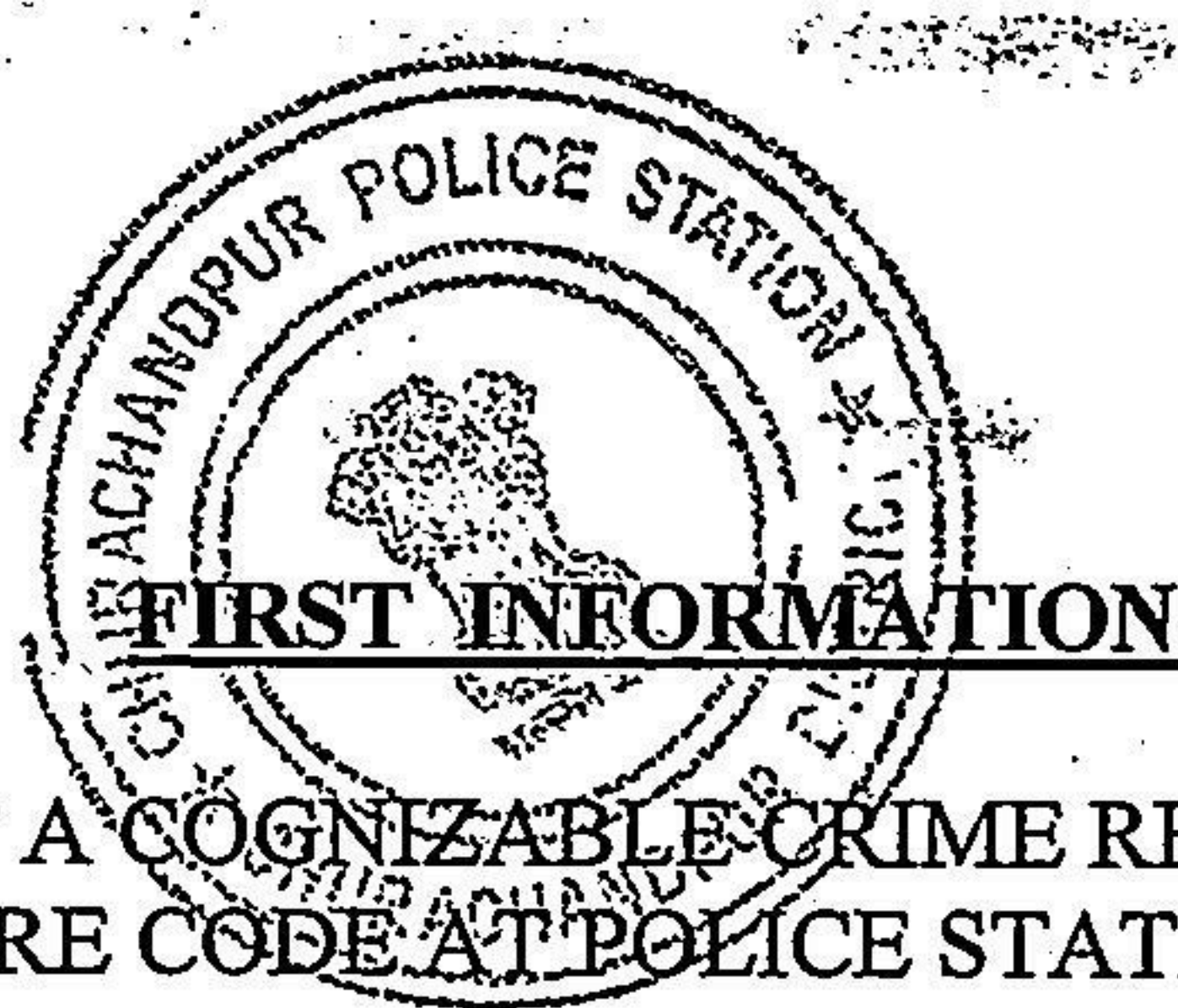

Sir,

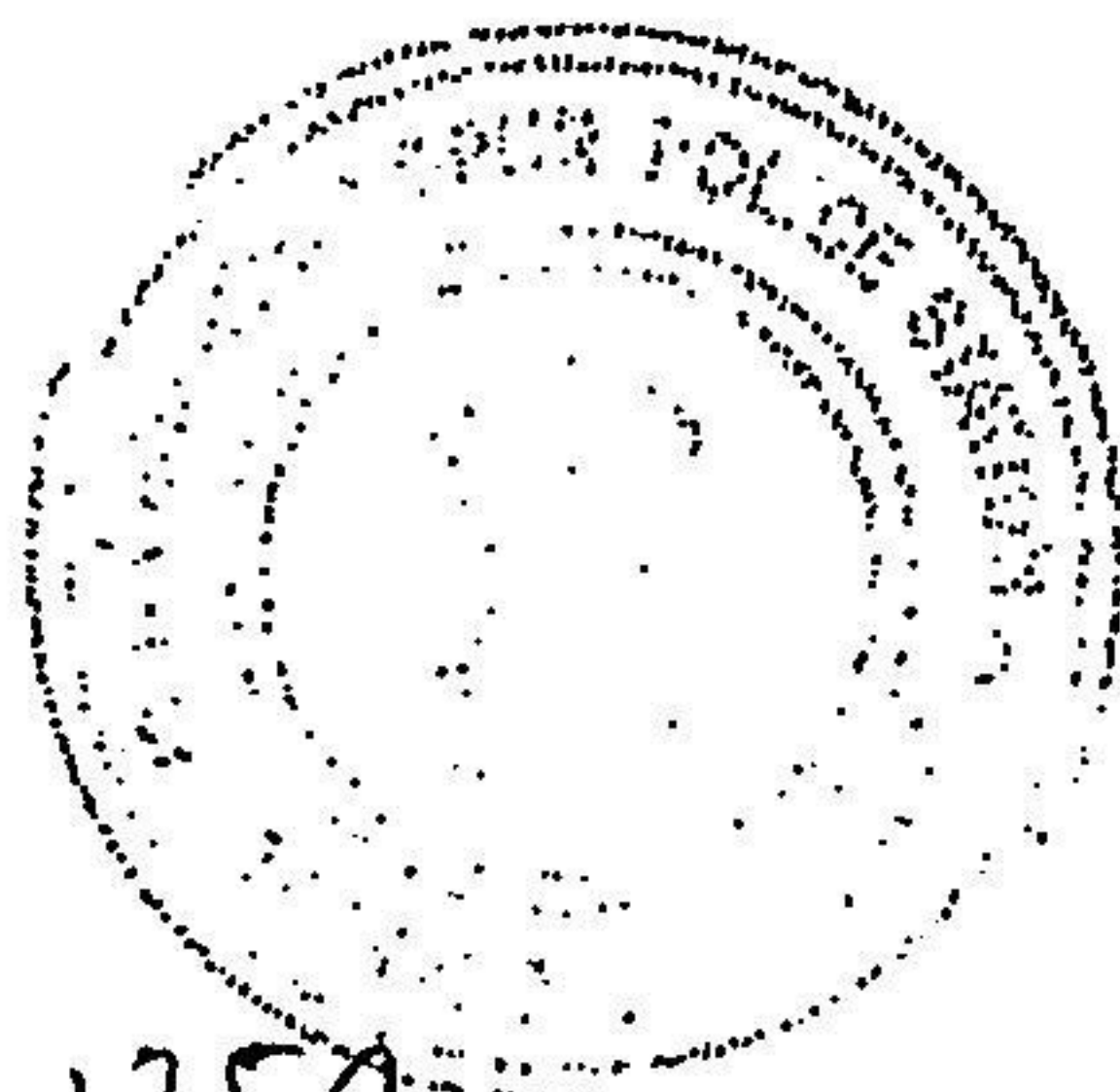
I am to bring to your notice that on the ... 03 May ..., 2023 at ... 6:00 pm ...
