Churachandpur District, Churachandpur
That at about 10:30 am/pm on the 3 May 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along wir various state forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked or villages and in the process, they have looted, vandalized and torched my house.
3. That, it may be reported here that the above said criminal activities have caused grave mental ago and incurred huge loss which may be estimated to be Rs 28,90,000 (Rupe Twenty eight lake nevery thousand) only.
4. Fortunately, me and my family managed to escaped from these criminals who even tried to kill burn us alive, and now currently taking refuge at P. Kamdou Verg Cepus.  In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And,
