I the undersigned Mrs. Boboi w/o (Late) P. Mawia Vaiphei would like to complaint against an unknown miscreant for burning my house at Thengra Leirak on 03/05/2023 at around 3:30 pm. On the right of my house lies the residence of Mr. Chaoba and Mantop to the left. There was three wooden house in the premises and all were gutted. My house was rented to Mr. Okendro a Donbosco Teacher who have been running Hostel for the past many years.

I have been living at Vaiphei Enclave, 91-Meitei Langol, Imphal West till my house was burned by mob from Meitei community as communal violence surge in the State. I along with my family took shelter at CRPF camp Lamphel for some time and later fled to Nagaland. I couldn't report the matter in time as I was traumatised from the incident.

I therefore urge you to take swift action to bring these criminal to justice.
