Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Zou Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of L. Awnchinkap Village, P.O., P.S. & District-Churachandpur, Manipur.

That, on the 4th of May, 2023, at about 5:30 PM, my house which is located at Thingkangphai Village (near the Chief's house), P.O., P.S. & District- Churachandpur, which I gave it on Rental to a family belonging to the Meeitei/Meitei community was destroyed and burnt by an angry-mob, worth Rs.29,00,000/- (Rupees Twenty-Nine Lakhs) Only, bearing Patta No.637 & CS Dag No. 1147/1270, which occurred due to the ethnic crisis.

In the given circumstances, I humbly pray you to kindly register an FIR and investigate the matter as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
