Subject : Report on looting, vandalism and burning of Church building and its properties.

Sir,

I, the undersigned have the honour to state the following for your kind intervention and favourable action seeking for registering an FIR and investigate the matter by due process as per law:


1. That, I, Shri Obed Paogoulien Singson S/O (L) Lungchinpao Singson, aged about 28 years, belonging to the Thadou-Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am the District Ministry Facilitator of the Church of the Nazarene International, North East India, Hmar veng, Churachandpur, Manipur – 795128, and hereby, competent to file a complaint on behalf of the Church.
3. That, at about 09:00pm, on the 4th of May, 2023, one pucca store building registered in the name of the said Church Bearing Patta No. 621/3066 under Dag No. 3967/5571 situated at Hmar veng, opposite District Transport Office (DTO) Churachandpur, Manipur – 795128 was looted/vandalized by some unknown miscreants and an approximate amount of Rs. 3,50,000/- (Rupees Three Lakh Fifty Thousand) only was lost in the said event.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority Meitei/Meitei community, I am filing this report on behalf of the Church, with a request to kindly take necessary legal action against the perpetrators as per the law.


