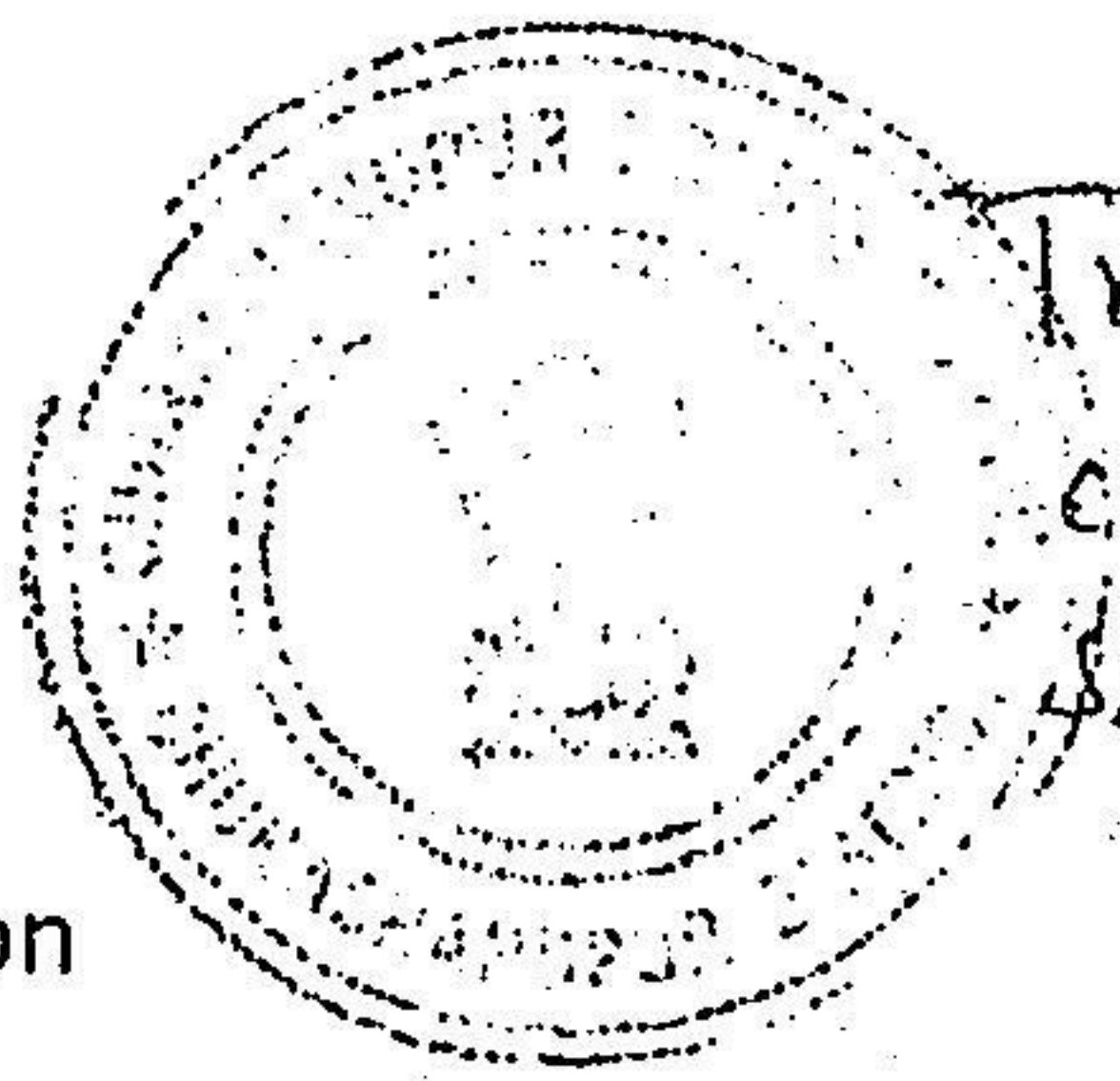

Wherein, a large gathering mob of Meitei Community conspired and instigated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attacked on our village H. Kotlen PO Chehjong PS CCPur. District CCPur. Wherein, they started vandalizing, ransacking and burnt down my/our Village rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 6 (male) 4 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre M. SONGGEL

That, the assets/properties and damages were estimated to Rs. 678,000

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abettors for their heinous acts carried out against me and my family.
