Subject:- Report on looting, vandalism and burning of integrated farmhouse, all its properties/assets.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I Seigoulen Lhungdim aged about 25 years, of age S/o Ngamlet Lhungdim, belonging to the Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**. and that, I am a permanent resident of M Songgel Village, P.O./P.S. and District, Churachandpur, Manipur-795128.
2. That, at about 11 pm on the 25th of May 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with State Forces attacked my Integrated Farm situated near P. Minjang village, Churachandpur, under the jurisdiction of Kumbi Police, Bishmujpur District, Manipur and in the process, they have looted, vandalized and torched the said farm and an estimated value of Rs. 8,40,000 was lost and gutted down by the said miscreant.

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
