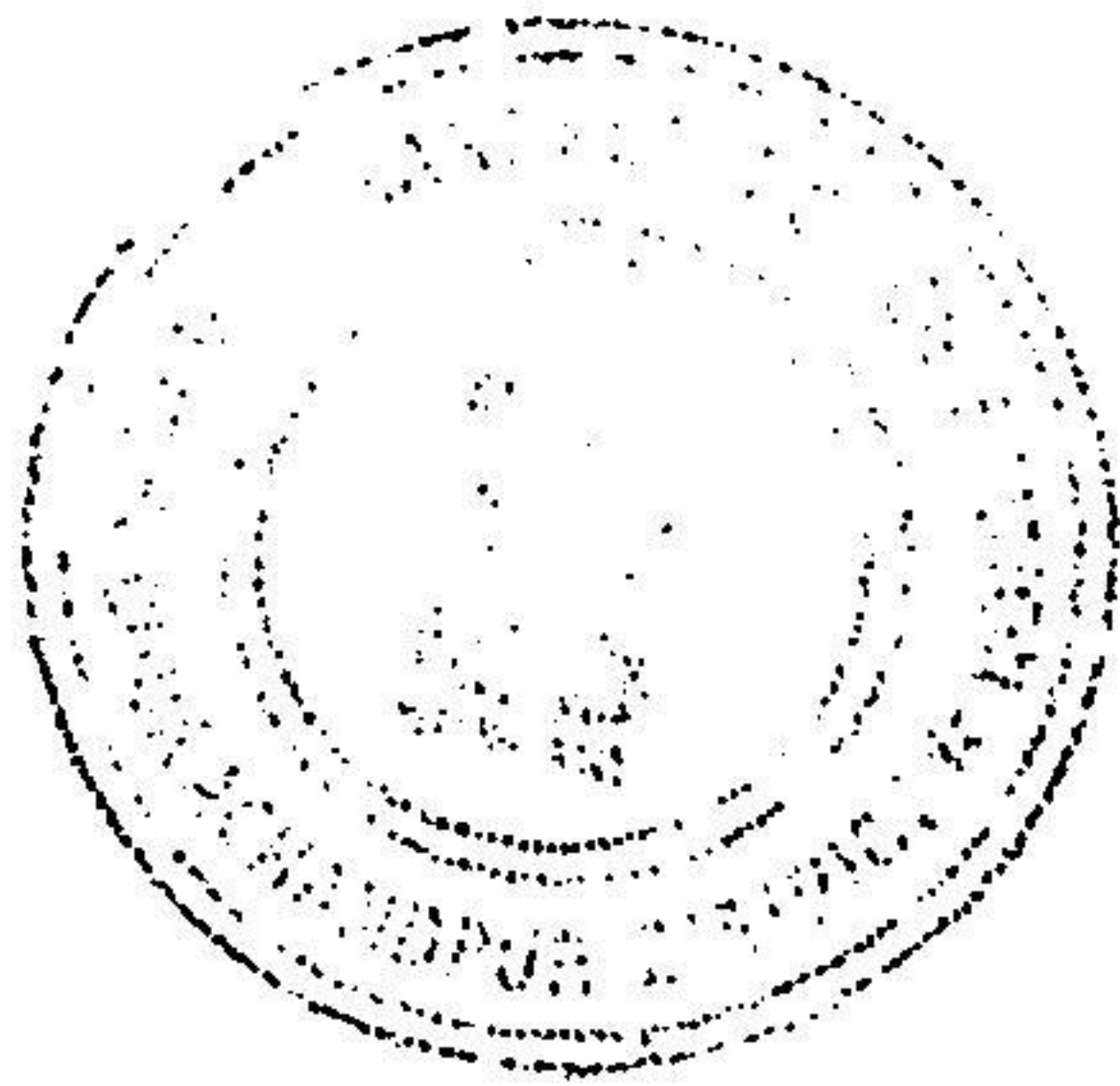

Subject: - Complaint/ Report on the crimes of **vandalism, looted and arson attack and discrimination of Scheduled Tribes.**

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the **Kuki Tribe**, which is a recognized Tribe under the Constitution of India.
2. That, on the **3rd of May, 2023**, at about **5:30 PM**, a huge contingent of armed radicals suspected to be members of the Arambai Tenggol and Meitei Leepun along with the Local Meitei / Meeteis looted, vandalized & torched my upcoming Variety-Shop yet to be opened, where the Autonomous District Council, Churachandpur (ADC,C) documents for my Variety-Store was still on pending for registration which is located at Torbung Bazar, **P.O.- Kangvai, P.S. & District- Churachandpur, Manipur.**

That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and the total loss suffered is estimated to be about **Rs.11,60,000/- (Rupees Eleven Lakhs Sixty Thousand) only.**

In the given circumstances, I humbly pray you to kindly register **an FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
